Guidelines for U15 competitions are as follows, however individual competitions may choose to utilize other distances and faces.

The **40m Round** for Recurve U-15 consists of 72 arrows shot at **40 meters** on the 122cm target face.

The 40m Round for Barebow U-15 consists of 72 arrows shot at 40 meters on the 122cm target face.

The 40m Round for Compound U-15 consists of 72 arrows shot at 40 meters on the 80cm target face (6 rings or full face)

Guidelines for U13 competitions are as follows, however individual competitions may choose to utilize other distances and faces.

The 30m Round for Recurve U-13 consists of 72 arrows shot at 30 meters on the 122cm target face.

The 30m Round for Barebow U-13 consists of 72 arrows shot at 30 meters on the 122cm target face.

The 30m Round for Compound U-13 consists of 72 arrows shot at 30 meters on the 80cm target face (6 rings or full face)

6. Reason

The Target Archery Committee (TAC) has reviewed U15 and U13 recommendations from its committee members in the Americas, Europe and Asia. The TAC members have found from multiple coaches and clubs that based on their experience (including some extensive experience with longer distances), the proposed distance encourages healthy form development by growing bodies as well as encourages participation by a wide variety of youths. The distance also helps with tournament set up and provides a progression to the U18 distances. Note that the distances are guidance and not for world record competitions. The guidelines recognize that a competition may wish to use others distances as appropriate for their circumstance. As an example, a tournament organizer may wish to use a shorter distance for Barebow.

The TAC recommends a vote for this U15 and U13 rules amendment and no vote for other U15 distant amendments.

Comment: Target Archery Committee submitted originally the U15 and U13 amendments separately, but this complicates the voting process, so these were merged together. However, Target Archery Committee finds if the Congress does not agree with U13 addition, but would agree with U15 distance change – the voting process should be enabling it to be approved.
