Deadline for submission by e-mail (congress@archery.sport) is **28 April 2023** (24:00 Lausanne time). Upon receipt a confirmation will be sent that the candidature has been received. As soon as the Electoral Board has validated the eligibility the status will be updated, and the form will be published as part of the Congress documents. This form will be published without the personal data. Only in case insufficient valid candidatures are received a 2nd round will be opened after the 29 April 2023.

It is reminded: a person cannot be candidate for more than 2 positions. (If a candidate is candidate for 2 positions, then 2 forms must be completed)

This document needs to be signed by 3 persons:

- The candidate (page 8)
- The president or secretary general of the member association, or Executive Board Member presenting the candidate (page 1)
- The president or secretary general of the member association of which the candidate is a member, could be same person as previous (page 9)

Definitions:

The following is a non-exhaustive list of examples of circumstances in which conflicts of interest could arise: personal and/or material involvement as an employee, contractor, director, trustee, shareholder, partner or other position with suppliers to World Archery, sponsors, broadcasters, or other parties contracting with World Archery or any other organisation or person likely to benefit from the assistance of World Archery (such as a subsidy, approval or election).

It is important that World Archery not only promotes the sport at the highest level, but also develops services and supports its member associations to develop archery in all countries. I would also like to be attentive to the needs of the member associations as each one has different situations and financial resources which influence their needs and expectations from World Archery. In addition to being attentive to the needs of member associations, I also wish to put forward some ideas and proposals:

Promote the organization of secondary competition during the World Cup to allow young talents from the host country to shoot some matches in the field in the evening or after the official matches. The objective is to promote young athletes and offer them an experience in a unique environment.

To promote the organisation of competitions for young athletes (U15) at national and continental level to enable them to gain experience and then consider an international career.

To continue to promote open competitions for popular sports at the international level such as the World Series or the World Master Games in order to encourage the practice of archery by the population and to allow athletes to meet international and famous athletes.

Continue the work done to obtain a second discipline (Compound) at the Olympic Games and consider the integration of other disciplines at international level (championships)

Clarify the rights of use of images produced during competitions by member associations so as to enable them to promote within their country or to the national media when their national teams participate in a competition or championship.


