1. I declare that I have read and that I have full knowledge of the provisions of the Rulesand Regulations for the Event currently in force and I agree to comply with all such provisions and, in particular (but without limitation), with provisions of the Rules and Regulations regarding (i)

eligibility for participation in the Event, (ii) ethical standards, fair play, appropriate behaviour and respect for others, (iii) anti-doping (iv) the media, and (v) all and anyrestrictions and/or prohibitions on forms of personal advertising, branding, sponsorship, endorsement, publicity or propaganda on persons or on clothing and equipment worn or used at the Event. I declare that I have full knowledge of all such provisions and that all provisionsapplicable to my participation in the Event have been specifically brought to my attention by my Member Association and are specifically approved by me.

- 2. I agree that I will abide by all reasonable directions given to me by Event officials, of World Archery, and/or the Local Organising Committee and that I will familiarise myselfwith and abide by all guidelines, rules, regulations, protocols and other directions issued inrelation to the Event at any point in the future.
- 3. I further agree to fully comply with the provisions of the World Anti-Doping Code in forceat the time of the Event as well as the World Archery anti-doping rules applicable to the Event. I am willing to submit to any tests (urine, blood, or other that are recognised by the World Anti-Doping Code) carried out at the event and to inform my team doctor of any medication I take.
- In consideration of the acceptance of my participation in the Event, I agree to be filmed, televised, photographed, identified, interviewed and otherwise recorded during the Event for the purposes of the international media coverage of the Event (by means of all and any media throughout the world in perpetuity) and the promotion of the sport. I hereby assign with full title guarantee in perpetuity to the World Archery Federation all rights of any nature in any such recordings. I agree that my name and image and any photographs and moving images taken of me (or other representation of me) at the Event may be used by World Archery and/or Local Organising Committee for the purposes of publicising the Event and promoting the sport and that they may be used by official sponsors or other commercial partners of the Event on a free of charge worldwide basis for the purpose of promoting their sponsorship of/official relationship with the Eventprovided always that any such use by Event sponsors/commercial partners of my image shall be limited to images of me (together with use of my name) taken or recorded whilst participating in the Event and shall not constitute an endorsement of their products and services by me. I additionally consent to the use and reproduction of my name, image and photographs of me in merchandise and publications relating to the Event including without limitation computer games and publications provided always that such merchandise is primarily related to the Event itself as opposed to me personally. I agree that all photographs and moving images taken by me at the Event, including those of athletes competing at the Event, shall be used solely for personal use and non-commercial purposes, unless prior written consent is obtained from the World Archery. agreethat under no circumstances, throughout the duration of the Event, may I act as a journalist or in any other media capacity without the express permission of World Archery.
- 5. I agree that World Archery, and any third parties contracted by World Archery, may collect, store, process, use and disclose to third parties any personal information including without limitation historical and statistical data ("the Personal Data") related to my participation in any International Event, as defined in the World Archery rules, to the extent necessary to facilitate participation in, and/or the organising of such events, and promotion of the sportby World Archery and may create and keep up to date my Personal Data on sportsdatabases, and may use such Personal Data in any other way in which I have or will provide my express consent or as may be required by law. I am informed that I am entitled to withdraw at any time the agreement provided in this clause, by written and signed communication sent to World Archery. In case of suchwithdrawal, I would no longer be allowed to participate in any International Event, asdefined in the World Archery rulesI am also informed of my right to request that all my Personal Data collected by World Archery or any other Organiser, in relation to my participation in any International Event, beerased, if and when such data are no longer relevant to World Archery or to any other Organiser for the purpose of the organisation of any other World Archery competitions or forthe promotion of the sport of World Archery.

- 6. I agree that I will accept any prizes or awards given to me by World Archery or thesponsors of the Event for my participation, and I will attend all special award ceremonies at which prizes or awards are presented. If I am requested to attend a press conference by World Archery or its representative I will (without any delay) attend this conference. I acknowledge that by not doing so sanctions may be imposed. I also agree not to participate in, support or promote betting related to the Event.
- 7. I acknowledge and agree that:
  - a. I participate in the Event at my own risk and that I will take all reasonablemeasures to protect myself from the risks of participation;
  - b. I am responsible for all property I bring into the Event sites and that the WorldArchery Federation and the Local Organising Committee for the Event shall have no responsibility for any loss or damage of this property.
  - c. neither the World Archery Federation or Local Organising Committee shall be obliged to arrange any insurances connected with my participation in the Event, including without limitation travel insurance and medical insurance.
- 8. I irrevocably release World Archery and the Local Organising Committee (and their respective members, directors, officers, employees, volunteers, contractors or agents) from liability (to the extent permitted by law) for any loss, injury or damage that I may suffer in relation to my participation in the Event.
- 9. I acknowledge and agree that my participation in the Event is conditional upon myvalid acceptance of and my compliance with each and all of the provisions of this entry form and this entry form constitutes a valid and binding contract that will remain valid for future events organised by World Archery unless I am required by World Archer to enter into a new participation agreement for any such future events.
- 10. I agree that any dispute, controversy or claim arising out of, in connection with, or onthe occasion of the Event, not resolved after exhaustion of the legal remedies established by my National Sports Federation, the World Archery Federation, and/or the Local Organising Committee, shall be submitted exclusively to the Court of Arbitration for Sport (CAS) for final and binding arbitration in accordance with the Code of Sports related Arbitration. The decisions of the CAS shall be final, binding and non-appealable. I shall not and I hereby waive my right to institute any claim, arbitration or litigation, or seek any other form of relief, in any other court or tribunal.
- 11. The Member Association hereby certifies and guarantees that all the relevant rules including all those referred to above, have been brought to the attention of the participant.
