I. CONTEXT

The Local Organizing Committee, in cooperation with the local health authorities has developed this COVID 19 Protection Plan which establishes the principles, protocols and general guidelines to be followed by all participants before and throughout the event. This document aims to inform participants about the measures put in place reduce the possibility of viral transmission to a minimum during the Event.

These measures complement the sanitary requirements prescribed by public authorities.

Please take time to understand the plans and steps you must take and rules you must comply with before you travel and throughout the length of your stay in Paris. It's crucial that you take personal responsibility for your part in the plan. Non-compliance with the rules outlined in the COVID-19 Protection Plan may expose participants to consequences that may have an impact on their participation in the Final Qualification Event and / or Paris 2021 Hyundai Archery World Cup, their access to the competition venue and official hotels and their participation in the event. Repeated or serious failure to comply with these rules may result in the withdrawal of their accreditation and their right to participate in the Event.

This document will be accompanied by a "Population specification" document presenting the specificities applicable to each type of population taking part in the event. The health protocol applied to the general public will be established according to the obligations presented by the competent authorities.

Given the changing nature of the COVID-19 pandemic, the event's COVID-19 Protection Plan is a dynamic document that is subject to change in response to any circumstances that may arise prior to or during the event.

This document is binding to all officials (World Archery staff, team officials, judges, guests) and athletes registered for, competing or otherwise participating in one or both competitions. These regulations are also binding to all staff and volunteers associated with the organising committee.

Participants must declare their understanding of these requirements and must return a signed copy of the *COVID-19 protection measures declaration*, which is attached as annex A, to World Archery in order to activate their accreditation for each competition.

Non-compliance with the obligations set out in this protocol may lead to **disciplinary action** as detailed in the disciplinary section of this document.

II. DEFINITION

Event: Final Qualification Event and Paris 2021 Hyundai Archery World Cup

Participant: Any person accredited or with a valid access device to the event (teams, World Archery Officials, LOC members, providers, volunteers, media)

Event Period:

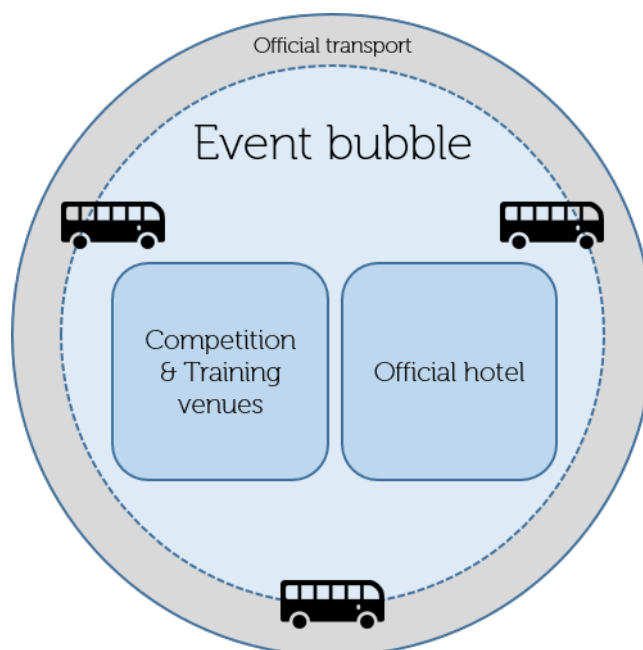
- Final Qualification Event: 18th to 21st June 2021
- Paris 2021 Hyundai Archery World Cup: 21st June to 27th June 2021

Organisers: the Local Organising Committee (LOC) and its representatives responsible for the Event.

Locations:

- Competition & Training venue = Stade Charléty (99 Boulevard Kellermann, 75013 Paris)
- Training camp venue = Centre Technique et Sportif de Tir à l'Arc (Avenue Champlain, 94430 Chennevières-sur-Marne)
- Official hotel = Ibis Porte d'Orléans (33 Rue Barbès, 92120 Montrouge)
- Official Airports = Aéroport de Paris - Charles de Gaulle / Aéroport de Paris - Orly

Event bubble: In order to contain the spread of COVID-19, local authorities impose restrictions on the activities and travel of participants outside of the Event Bubble comprising the official hotel, training and competition venues and any other venues used for the event:



III. COVID 19 TESTING & PROTOCOLS

1. Protection measures

All participants taking part in the Event are expected to abide by the following practices, regardless of their function and role, in order to protect themselves and other participants:

- Wash/sanitize your hands frequently, especially if you have had contact with another person or an object of common use and when you enter a new area.
- No handshakes. Use a contactless greeting. Always wear a surgical mask when outside of your hotel room, changing the mask every 4 hours and/or if the mask is soiled or damp ([see WHO guidance on wearing a mask](#)). It is important you make sure you have access to enough face masks (surgical masks) to last through your stay in France. Everyone is responsible for their own supply.
- Proactively monitor their health for any COVID-19 symptoms (World Health Organization Website: https://www.who.int/health-topics/coronavirus#tab=tab_3)
- Always cough into your mask, sleeve or a tissue.
- Maintain social distancing as much as possible (minimum 1,5 meters), especially during mealtimes and on transportation services. Avoid meetings in small areas.
- Practice routine daily hygiene (recommend showering at the start of the day and after physical activity).
- Sanitize/disinfect personal items frequently, including your mobile phone, accreditation, water bottle, pens, etc.
- Avoid sharing your personal items with others (mobile phone, water bottle, pens, etc).
- Always wear your accreditation to confirm that you are part of the “event bubble” (hotel, transport, and venue).
- Carefully respect all instructions and requirements set forth by the Organizer.
- Strictly follow the “Event Bubble” principle of operations for the best protection of all participants.
- Any activity or travel outside of the “Event Bubble” is prohibited. If an emergency arises, any travel or activity outside of the “Event Bubble” must be declared and validated by the LOC COVID-19 manager (Luc LENGLET - +33 7 64 35 86 15 – llenglet@spartner-agency.com)

2. Upon arrival testing

All participants entering the event are required to present a negative PCR test dated less than 72 hours and to take a mandatory upon-arrival COVID 19 antigen PCR test which will be performed at the official hotel or at the competition venue.

3. Temperature checks

All participants will have temperature checks randomly performed at the hotel or at competition/training venue. Those temperature checks will be managed by the LOC staff and volunteers). If a temperature is recorded at 37,9°C or higher, an antigen PCR test will be performed.

4. COVID 19 symptoms

COVID-19 symptoms include the following (refer to the [WHO web page](#) for more details):

- Fever of 37.9 ° C or more
- Cough
- Sore throat
- Shortness of breath
- Muscle pain
- Headache
- Diarrhea and / or vomiting
- Sudden loss of taste or smell.

If a participant observes any symptoms by himself or by a third party, a doctor of the organisation will be permanently available to examine the situation. A test can then be performed on request.

5. Red flagged countries

The French government has set up a specific regulation for people from 15 countries. These same regulations apply to people who stayed in the last 30 days in these 15 countries.

The list of countries concerned is as follows:

People coming from / having stayed in these countries will have to be tested every day via a PCR test.

This test will allow the 10-day quarantine requirement to be waived and integrated into the period of presence at the event.

6. COVID 19 testing

Testing will be a crucial part of minimizing transmission: used for general screening during the event; as well as used for diagnosis for those experiencing symptoms of COVID-19.

The results of the tests will be communicated to the participants' relevant Team Manager. The Team Manager will receive all results about his group, and each individual participant will receive their personal result.

Each team manager will receive a PCR testing program according to the team's timeline (arrival/departure,...)

7. Positive COVID 19 test result

In the case of a participant with a confirmed positive PCR test for COVID-19 after an antigen PCR Test or a PCR test, he will:

- 1) Be immediately placed into isolation in a new room
- 2) He will be taken immediately to a doctor for examination

- 3) Depending on the doctor's examination conclusion, actions to be followed will be defined

If a participant is definitively positive, he will have to be placed in an isolation hotel at the expense of the participant / travel insurance if applicable, or at the designated hospital if needed. He will not be allowed to return to their respective country until their isolation period has been completed.

The LOC COVID-19 Manager will follow up on the patient's situation directly with the relevant Team Manager.

All individuals placed in isolation should be isolated for 10 days and not have any contact with any other individuals during that period. As per France's local regulations, if the participant has not presented symptoms after 10 days of isolation, then the participant can stop his isolation. **The termination of the quarantine period should be determined by the doctor appointed by the French Government.**

As a result of any isolation periods, the LOC will liaise with the hotel and support the National Federation with requirements. **Participants must ensure they have appropriate medical insurance to cover routine medical healthcare, including COVID-19 care, hospitalization and, in case of isolation, that such insurance cover has no exclusions or limitations regarding the length of stay, as all costs related to a positive COVID-19 will have to be borne by the participant.**

8. PCR test result communication

For teams the communication flow will be presented during the Team Manager meeting.

For other Participants, the PCR test results will be available on the internet.

9. COVID 19 testing area

The COVID-19 testing area for the event will be located in two temporary facilities: competition venue and the official hotel.

10. Symptoms protocol

If any participants has symptoms, he shall immediately:

- 1) Inform the LOC COVID-19 Manager
- 2) Isolate himself at the official hotel in a separated room
- 3) Have a COVID test at the official hotel or competition venue

11. Close contact definition

There are two types of close contact:

- Risked close contact :

Anyone who shared the same living quarters as the confirmed or probable case

Any person who has had direct face-to-face contact with a case, within 2 meters, for any length of time (e.g. conversation, meal, physical contact). On the other hand, people encountered in a public space in a fleeting manner, even if they are not wearing a mask, are not considered to be at-risk contacts

Any person who has performed or received acts of hygiene or care

Anyone who has shared a confined space (office or meeting room, personal vehicle, etc.) for at least 15 consecutive or cumulative minutes over 24 hours with a case or who has been face-to-face with a case during several episodes of coughing or sneezing

- Unrisked close contact

All other contact situations

Any person with a history of SARS-CoV-2 infection confirmed by molecular amplification, antigenic test or serology within the last 2 months

If a participant is considered as a “risked close contact” he will have to be isolated and tested daily (PCR test). If his test is negative, the participant can stay in the event bubble.

Any risked close contact shall:

- 1) Be immediately placed into isolation in a new room
- 2) He will be taken immediately to a doctor for examination + have a PCR mandatory test
- 3) If the PCR test is positive see 7. Positive COVID 19 test result. If the PCR test is negative, he will have to stay in a single room and have daily PCR tests.

If a team member has a positive PCR test result, his entire team will be considered as close contact

12. Departure Test

A COVID-19 PCR test to enter home country of transit or final destination and the necessary documentation can be arranged through the LOC. The LOC will facilitate the opportunity to be provided with duly signed medical certificates (presence of medical doctor may be arranged if required).

Those tests will be organized at the Official hotel or Competition Venue according to the departure schedule. Departure tests remain at the charge of the person taking the test (cost of the test fee for the whole event is 70 EUR per person and must be booked through WAREOS).

IV. PRIOR TO ARRIVAL

1. General information

The journey does not begin upon arrival in France. Starting now, participants should ensure they take time to read and understand the steps that have to be followed prior to their arrival in France. All event participants should:

- 1) Monitor their health status continuously, including taking their temperature and monitoring for any symptoms (World Health Organization Website: https://www.who.int/health-topics/coronavirus#tab=tab_3) from 14 days before the event.
- 2) Limit their social interactions as much as possible from 14 days before the event.
- 3) Make sure they know the latest information regarding COVID-19 testing and certificates required by their airline/train company.
- 4) Make sure that they have completed the necessary steps should they need to apply for a Visa and/or Compelling Reason to travel to France (refer to section 4 and 5 of the [Team Delegations' Handbook](#)).
- 5) Have travel insurance that covers COVID-19 care.
- 6) Take a COVID-19 PCR test within 72 hours of departure for Paris. The certificate must contain the relevant information in French or English. All pre-arrival tests are the full responsibility of the respective team delegations, including the financial responsibility for issuing the tests. For any arrival by car or train, participants will need to bring with them a print copy of their negative test result.
- 7) Complete [the Sworn Declaration](#)

IMPORTANT:

All participants must fulfil all the above requirements as well as the "Arrival" procedures describes in this document to enter France.

DO NOT TRAVEL TO FRANCE IF YOU:

- Experience any COVID 19 symptoms within 14 days prior to departure
- Are self-isolating as a result of COVID 19 symptoms or have been in contact with someone who has had symptoms
- Have had a positive PCR test within 14 days prior to departure

2. Pre event arrival/training camp

It is possible for a team to arrive earlier in France in order to have a preparation period/training camp.

Training camps will be held in the Centre Technique et Sportif de Tir à l'Arc (Avenue Champlain, 94430 Chennevières-sur-Marne)

Teams must use official hotel and officials transports during the training camp.

Lunch boxes will be available at the hotel in the morning. Dinner will be served at the official hotel.

All COVID 19 guidelines must be respected during training camps as well.

V. ARRIVAL

Upon arrival, participants must observe the instructions of the French authorities and be ready to show to immigration:

- A valid passport and or ID card for European Union citizens. Passports must be valid for at least six (6) months from the date of arrival and must contain blank page(s) for migration stamps. (Physical)
- The 72h negative PCR test result certificate (electronic **and** hard paper copy);
- The Sworn Declaration;
- The Laissez-passer (if applicable) ;
- The visa (if applicable) ;

- The upon arrival-quarantine exemption (if applicable);

From the airport or the train station, participants will be transported to the official hotel for the mandatory upon-arrival Antigen PCR test which will be performed at the Official Hotel.

Participants arriving by private vehicles should drive directly to the Official hotel. Once the upon-arrival test is confirmed negative, participants should only use the official event transportation and must leave their vehicle(s) at the official hotel. The parking area will be secured, and participants need to provide the car's number plate details before arrival.

VI. DURING THE EVENT – OPERATIONS

1. Transport

Wearing a surgical mask is mandatory within official event transportation.

No food/drinks are allowed in transportation.

All participants are required to sanitize their hands before entering the vehicle.

All vehicles will be disinfected at the end of each journey. At the end of each day vehicles will be thoroughly disinfected.

Drivers will ensure they have a clean and disinfected vehicle between each trip. Whenever possible, they should open windows of the vehicle to facilitate ventilation.

Every vehicle will be large enough to respect social distancing and separation between groups.

IMPORTANT:

All participants must use the official transportation provided by the LOC during the event and no other private or public transportation means.

a. Arrival & Departures

Upon arrival at the airport/train station, LOC volunteers and staff will guide participants to their respective vehicles.

Participants will have to carry their own bags - the driver will not be allowed to touch them.

Participants will be transported in the event official transport shuttles to the official hotel for the upon arrival COVID-19 Antigen PCR test.

b. Ground Transportation

The LOC will organize transportation between the competition venue or training area and the official hotel.

Shuttle timetables will be displayed on information boards in the lobby of each hotel, where volunteers will be available to provide guidance and information.

2. Accommodation

The official hotel will be exclusive and only accredited participants will be allowed to enter the hotel.

Upon arrival at the hotel, a simplified check-in process will be implemented. Room keys will be ready in an envelope and only one participant will be required to go to the check-in.

Upon arrival at the hotel, team members are required to present a negative PCR test dated less than 72 hours and to have an antigen PCR, they will have to wait for their results before leaving the official hotel.

Participants are strongly recommended to not enter room of other participants (except for Physiotherapy treatments).

The use of masks is mandatory in the hotels' common areas

Physical distancing measures will be implemented throughout the hotel

Sanitizing stations will be displayed near the front entrance and in the common areas

Increased cleaning and disinfecting frequency throughout the hotel, paying attention to high-touch items

Housekeeping team will change towels and ventilate the room every day. Housekeeping team will remake beds and thoroughly clean the rooms every three days. Participants will have the possibility to display a door hanger should they not wish to have housekeeping enter their room.

Hotel staff will follow the hotel protocols.

Dining areas:

- Use hand sanitizer when entering the dining area.
- Wear masks at all times, except when eating or drinking.
- Social distancing must be respected at all times.
- Tables will be spaced apart and participants should not move the tables and/or chairs.
- Tables and chairs will be cleaned after each group
- Buffet style service, but hotel staff will be serving the food
- It is advised that members from different teams shall not share tables.

3. On venue catering

There will be two separated meal areas in the competition venue: one for delegation (athletes/staff) and World Archery officials and one for volunteers, LOC staff and providers.

Only lunches will be served in the competition venue, buffet style in a specific area.

Catering staff members will wear face mask at any time and will serve each participant (no self service).

Specific lunch schedule might be mandatory in order to reduce wait and gathering.

Specific flow/pathway will be organized in order to reduce gathering.

Social distancing must be respected at all times.

Tables will be spaced apart and participants should not move the tables and/or chairs. Tables and chairs will be cleaned by the catering staff members after each group.

All individuals are responsible for throwing away their own trash at the exit and stacking their tray on the designated space prior to exit.

Anyone not eating or drinking must wear a mask.

Every participant must leave lunch table as soon as they finish eating.

4. Media

Media representative will have to follow French government guidelines in order to access competition venue. During the event, media will not be allowed to circulate outside a limited zone (press room, press stands and mixed zone).

In the mixed zone, medias will have to respect social distancing (minimum 1,5 metres) and wear a mask at all time. They will be asked to sanitize their microphones/recording devices before each interview. Athletes and/or coaches will also need to wear their mask. LOC staff will be there to oversee the operations.

5. Grandstands

In accordance with the French government guidelines, 1 000 people maximum will attend the event. Everyone will have to provide a 72h negative PCR test or a Vaccination certification or a COVID 19 remission certificate. Public will have to respect social distancing and will have to wear a mask at all times. Public will seat in a specific area in the grandstand.

Non-competing team delegation members will have a large well-identified designated seating area. Anyone sitting in the athlete seating area will have to remain 2-3 seats away from the next seated person.

VII. LEAVING FRANCE

It is the full responsibility of each participant to remain up to date on the requirements for entering their destination country, as well as any countries you will pass through in transit.

If you require a COVID-19 PCR test to enter your country of transit or final destination, please refer to the Departure test section in section 1.

You should continue to follow the Event protection plan – including hygiene and distancing rules – throughout your departure. Travel to the airport only using the designated transport service provided by the LOC.

VIII. DISCIPLINARY

World Archery is prepared to take any decision, including imposing sanctions if the reputation of World Archery or COVID-19 protection measures are jeopardised, to ensure that the health, safety and security of participants is not comprised during competition.

The failure to adhere to any of the obligations contained in this protection protocol may result in the immediate **disqualification** of the participant from the competition. In the event of disqualification, the participant shall immediately lose access to any competition or practice venues and shall not be permitted to interact with other participants.

In the case of officials, this may include the removal or deactivation of accreditation for the remainder of the competition.

In the case of athletes, the disqualification will apply to all events in which the athlete is competing (individual, team and mixed team). If any athlete is found to be in further breach of any obligations after disqualification, further action will be taken at later competitions.

Any verbal warning given by a World Archery official to a participant will lead to an email notification sent to the concerned person and copied to the team manager and member association.

A third warning will automatically lead to a disqualification from the event and open a disciplinary proceeding against the participant, which may result in **the suspension of the participant from the rest of the season**, depending on the circumstances of the violation(s).

Disciplinary decision concerning workforce will be handled by the organising committee.

Annex A

COVID-19 protection measures declaration

I affirm that I have read and understood the Event protection plan.

I acknowledge the risks of COVID-19 and, that even with the protocols implemented by World Archery, the local organising committee and local authorities, there is still a risk. I affirm my understanding that my participation in the Hyundai Archery World Cup is at my own risk.

I expressly agree that neither World Archery nor the local organising committee shall have any liability whatsoever in the event that I contract COVID-19 during the competition, and that I carry the relevant insurance coverage to cover any medical costs associated to COVID-19 or any other illness or injuries.

I understand that in the case I test positive or I am considered a close contact of a positive case, the decisions of the local authorities shall prevail over this protocol.

I acknowledge and agree that testing and daily health monitoring for COVID-19, including, but not limited to screening for body temperature, shall be performed on-site and that any and all results or other related health data including pathology and specialist reports may be collected by World Archery or medical personnel engaged by World Archery at the venue, where needed, and such information may be shared with World Archery, and that costs of such additional tests will be at my own charge.

I understand and consent that the use of my personal data will be in compliance with the General Data Protection Regulation (GDPR) and all relevant Swiss legislation. I acknowledge that World Archery has legal basis for holding and processing my personal data as it is in World Archery's legitimate interest for the protection of my health. I have been advised that my personal data will not be shared with any other third parties except the medical expert engaged by World Archery and the related local authority and will be destroyed by World Archery following the conclusion of the Hyundai Archery World Cup season.
