



# Executive board and executive committee decisions 2021-2023

Decisions taken after Congress 2021 / Updated: 11 January 2024



The following is a summary of decisions made during meetings and conference calls and decisions taken by postal vote.

#### **Executive Board - Lausanne - 5 December 2021**

## 12/13 voting members of the Executive board were present.

#### **Decisions taken:**

- 1. EB approves the nomination of Yuko Okura (JPN) & Thomas Aubert (FRA) as IF delegates: YFS
- 2. The Executive Board approves the second option which would allocate the team quota as follows: 3 places at World Archery Championships, 3 places at each continental tournament in Asia, Europe and Americas, 2 places at World Ranking list, 3 at the Final qualifying tournament, and 1 Host nation: YES
- 3. The Executive Board approves the qualification system principle as well as the system for the Paralympic Games: YES
- 4. Penalty fees for late registration of world ranking events 500 CHF: YES
- 5. Additional fee for management of doping control by ITA for world ranking events 780 CHF: YES
- 6. Archery international licence of 100 CHF: YES
- 7. To put in place a certification system of results providers for multisport games to ensure the quality of the events: YES
- 8. Procedure to have no mandatory equipment inspection during world cup events approved: YES
- 9. Approval of the idea of doing a quality questionnaire to our direct stakeholders and Carina Olsson will work with the Secretary General to supervise the process: YES
- 10. The Financial program was approved in principle pending finalisation of the loan agreements with the banks: YES
- 11. After a vote organised jointly on SurveyMonkey and by paper ballots, Gwangju obtained 10 votes and Madrid obtained 1 vote: YES
- 12. The Executive Board approved the allocation unanimously: YES

## **Executive Board Hybrid Meeting - 20 April 2023**

## 9 Present, 3 excused, Vladimir Esheev not invited due to conflict of interest

Presentation on Revised budget which was accepted officially on 15 June. The Executive Board has been sent with the minutes the budget as shown in the meeting. Since no questions or objections were raised by the 15th June the budget was considered as approved.

After a presentation on RUS/BLR, the President called for the vote and Carina Olsson asked for the the floor and stated:

"I am against the possibility for Russian and Belarusians to be able to take part in World Archery's competitions, regardless if they are under neutral flag, or regardless who is the organizer of any



Multisport event in Archery, including the Olympic Games. I vote against this decision, and I want my statement to be noted in the minutes of the meeting"

The Executive Board then took the following majority decision (8 Yes/ 1 No):

The Executive Board agrees with the creation of a working group to finalise and implement the recommendations of the IOC Executive Board to allow neutral athletes from BLR/RUS to participate in World Archery competitions. The working group will base it work on the preliminary work done by the Secretary General and report back to the Executive Board in July also establishing a timeline for the potential return of the athletes. The Executive Board also agreed on the press statement. The composition of the working group will be:

- Chair: Mr Jörg Brokamp, Vice President
- Members: Mrs Crystal Gauvin, chair Athletes Committee; M. Jean-Michel Cleroy, EB Member; Mr. Tom Dielen, Secretary General and an independent member to be decided based on the company used for the vetting process.

## **Executive Board Meeting - Berlin - 26 July**

Decision of the EB The only conclusion is that for what concerns World Archery this is a pure Egyptian matter but that his accreditation as international judge ended automatically end of 2022 and that in case his sanction would be lifted and he would become again in good standing he would need to go through the regular process for new judges. For what concerns the Board of Justice and Ethics the board is now appointed and no longer elected and his term is no longer available.
