



Ad hoc committees



- Ad hoc committees are appointed for specific function for two-year terms (between congresses), unless specified otherwise.
- Next appointments to be made December 2023 for the following ad hoc committees:
 - Gender Equity
 - Sustainability
 - Masters

Term limitation – general rules



One term = four years

Limits:

- Committees and boards (except executive board)
 - Max four full terms in the same committee
 - Must have a minimum two-year break after two consecutive full terms
- The president, 1st vice president, vice president or executive board member
 - Max three full terms in the same position

Outgoing officer can be a candidate for a different position.

Term limitation - executive board



Effect in the next two congresses independent of outcome of elections:

- Ugur Erdener **last term** as president until 2025
- Maria Emma Gaviria last term as vice president until 2025
- Jörg Brokamp (2027) first term as 1st vice president (two more possible)
- Thomas Han (2025) first term as vice president (two more possible)

Last term as executive board member:

• Vladimir Esheev (2025)

2nd term as executive board member, one more possible:

• JM Cleroy (2027)

1st terms as EB Member, two more possible:

Carina Olsson (2025), PK Chiu (2027), Mark Miller (2027), Yuko Okura (2027)

Other:

- Darko Uidl (2025) 2-year term doesn't count for term limit
- Eva Thesen (2027) first term for Constitution and Rules committee
- Crystal Gauvin linked to athletes role

Term limitation - committees



Committee members

- Each committee has several members that will need to step down for two years or change committee in the next two congresses.
- A list will be produced, and a discussion will take place with the committees concerned during the joined committee meeting to guarantee a good transfer of knowledge.



Interpretations



What?

Clarification on current rules or bylaws

Who can submit?

- Member associations (fee will apply)
- Committees or partners (no fee)

How to submit as a committee?

- Coordinate with committee first and chair or deputy should be the one sending
- <u>In a proper form</u>, not as simple email text
- Send by email to <u>sluik@archery.sport</u> (good to copy C&R), not directly to other committees

Interpretations



Procedure

- Constitution and Rules Committee (C&R) defines which committee to answer
- Sent to committee chair with two weeks deadline to answer with possibility to notify if need longer time (not a problem, just need to inform)
- The committee gives an answer by email, keeping in mind the following:
 - Giving answer how to understand /interpret current rules
 - Not coming up with new rules
 - In case it brings up the need to change a law or bylaw, then committee need to submit bylaw or motion form
 - Answer must be approved by the committee, not just individual answer by the chair
- C&R to approve if the answer is according to rules and clear
- Before publishing **sent to all committees** with at least a week for feedback

Interpretations



Publishing procedure:

- Interpretations published twice per month (15th / 30th)*
 - On the <u>webpage</u> + integrated to online rulebook
 - In <u>documents manager</u>
- A notification always included in the <u>monthly newsletter</u> (sent directly to all member associations and to all World Archery officers)
- A notification always sent to judges committee by email

Social media and other communications



- Regardless of whether you are actively speaking on behalf of World Archery, the
 world will always see them as a reflection of our brand. If you are acting
 questionably online, this raises suspicion about World Archery too.
- Unless expressly authorised, only the president, the secretary general and the communications department are permitted to post material on a social media or other communications channel in the federation's name and behalf.

Furthermore, it always need to be coordinated with the communications team.

Be aware that the Internet is permanent.

Check your facts



- Respect the law (including copyright law).
- No abusive, discriminatory, harassing, bullying, derogatory, defamatory or inappropriate content. Remember that one of the key objectives of World Archery is not to allow any form of discrimination in its actions or decisions, be it discrimination of any kind such as race, colour, sex, sexual orientation, language, religion, political or other opinion, national or social origin, property, birth or other status. Anyone part of the World Archery Family commits themselves by their actions to behave in a non-discriminatory and ethical manner.
- Avoid saying negative things but especially no disparaging or defamatory statements about World Archery, our member associations, our athletes, our executive board or officers, employees, organising committees, member of the Olympic Family, other stakeholders, consultants and partners.

Check your facts (2)



- You are responsible for your actions. Anything you post that can potentially tarnish the archery's image will ultimately be your responsibility. We do encourage you to participate in social media, but urge you to do so properly, exercising sound judgment and common sense.
- Make it clear in social media postings that you are speaking on your own behalf, in particular write in the first person, use a personal e-mail address and it is advisable to include a disclaimer— e.g. "these views are mine alone, they do not reflect the views of World Archery." But even with that, what you say on social media (or anywhere else) is just as much of a reflection of World Archery as what you do in your personal life (to some extent).
- Let the subject matter experts respond to negative posts. You may come across negative or disparaging posts about World Archery (or archery in general), or see third parties trying to spark negative conversations. Unless you are a spokesperson (which are the president, the secretary general and the head of communications), avoid the temptation to react yourself. Pass the post(s) along to the communication department who are trained to address such comments.

Check your facts (3)



- Be conscious when mixing your business and personal lives. Online, your personal and business personas are likely to intersect. World Archery respects the free speech rights of all, but you must remember that member federations, our partners, our stakeholders, customers, colleagues and supervisors often have access to the online content you post. Keep this in mind when publishing information online that can be seen by more than friends and family, and know that information originally intended just for friends and family can be forwarded on. Remember to NEVER disclose non-public information of World Archery (including confidential information), and be aware that taking public positions online that are counter to World Archery's interests might cause conflict.
- Protect yourself. Be careful about what personal information you share online and ensure
 that your profile and any content you post are consistent with the professional image you
 should present.
- Avoid posting comments about sensitive related topics, such as our performance or make statements which cause, or may cause, harm to our reputation or otherwise be prejudicial to our interests.

DO's



- We encourage you to **share and cross-post any of World Archery's official communications** and in particular any video content and images posted on the World Archery social media channels. This helps to spread the World Archery communications. You can also post your own photos directly promoting the event such as the venue/field of play, competition images (ensuring they show a positive image) and event branding.
- **Support our top athletes** by liking or sharing their information on condition that it doesn't go against our objectives.
- Don't be afraid to ask questions or raise any concerns! We want you to feel comfortable engaging the communication team about social media and what you are sharing online. Reach out to your direct manager or reach out to the social media team.
- Inform us if your contact details have changed!

DON'Ts



- During events, no content should be posted from accredited/restricted areas, ie hospitality, doping control rooms, World Archery offices, etc.
- During events, no content should portray the consumption of alcohol or smoking, attendance at parties or receiving gifts/VIP treatment.
- In line with broadcast media rights, you **cannot publish video content** you may have filmed of a World Archery event.
- Any betting or proving information that could assist with betting in Archery

Social media and other communications



World Archery has a **social media policy**.



Communication




The chairperson of the committee/board reports to the executive board between congresses and to congress when congress is in session.
