SYDNEY 2000

ATHLETE ID

Your NOC will ask you to provide the Unique Athlete ID. The Athlete ID is used by the IOC and FITA to store information on the athletes and is unique for every archer.

Its composition is the following:

XX CCC G DDMMYYYY SS

XX = Sport Code (for Archery = AR)
CCC = IOC NOC Code (for the originating
country)

G = Gender (M or W)

DDMMYYYY = Date of Birth (day.month.year)

SS = Sequence Number (01-99). Normal In principle the sequence number will always be 01. If you have two archers born on the same day of the same gender you will allocate their sequence numbers alphabetically and you are requested to signal this to FITA.

Example:

For a male Australian archer, born 25 October, 1967 the identification number would be: ARAUSM2510196701

Participating Countries

The list of Countries participating has now been finalised and the following invitation places have been attributed by the IOC tripartite commission.

We want to repeat that countries that are in this list are requested to inform FITA before the 15th August who will be on their team to allow us to prepare the statistics on their athletes required for press coverage and inform us on the place and time of pre-olympic training camps in the Oceania Region.

Miscellaneous news from Member Associations

- The Israel Archery Association has informed us that the 16th Maccabiah Games will take place in Israel from the 16th July till the 26th July 2001. It is the first time in 30 years that archery will be included and all interested archers should contact the Israel Archery Association.
- The Archery Association of Singapore has informed us that a tournament is organised by another association called Archery Federation (Singapore), which is not a member of FITA, to be held on the 9-10th September in Singapore. The invitation to this tournament mentions that this is a "FITA Sanctioned event". This is not the case since this association is not a member of FITA. The organisers have been informed that they cannot use the name FITA related to this event and this competition is not recognised by FITA in any way.

Corrections on the Rule Book

 In the French translation book 2 an error was made in art 4.4.1.2 where it mentioned that Men Cadets should shoot 90m, 70m, 50m and 30m.

It should read that for Cadets Men the distances are 70m, 60m, 50m and 30m just like for the Cadets Women.
