Please take note that the FITA Office will close on 21st December 2001. We will all be back on 2nd January 2002 to start the New Year.

Interpretation

The question was raised whether an archer, who has not been able to shoot all his arrows because there was an error in operating the timing control system and the yellow light phase was too short, should be given extra time.

Article 7.5.4 clearly indicates the limits of the shooting time, however it also indicates that there can be exceptions to the rule (7.5.4.6) and that there "shall" be a visual warning signal 30 seconds before the end of the time limit (7.5.4.7).

The C&R Committee is unanimous in its opinion that the archer should be given extra time.

Where there are no digital clocks operating, the archer must be able to rely on the proper functioning of the visual and acoustic timing control devices, thus on the yellow light phase being 30 seconds, and adjust his shooting accordingly.

Mistakes of the timing device or errors made when operating it are outside the control of the archer and arrows that were not shot as a result of those problems should therefore be treated like make-up arrows (7.5.4.1).

Please note this interpretation applies only where there are NO digital clocks, only the lights and sound signals.

MAS Management Seminar in Nymburg

Council approves Member Associations Management Seminar.

FITA Council has decided to host in 2002 at the conclusion of the World Junior Championships a Management Seminar as a service to our Member Associations. We will send you an official invitation in the month of March but we wanted to inform you on this important subject. The seminar will handle different topics on media, marketing, internet, human resources of volunteers and professionals, and a discussion will take place on how FITA and its members can achieve their common goals. The Swedish Archery Federation has decided to sanction Mr. Anders Grönberg's for a period of 70 days starting from the day of the test, which means from 14th September 2001 until 23rd November 2001,

days of the junior championships.

and has issued a warning that if Mr. Gronberg commits a doping offense within one year of this sanction this will be treated as a 2nd offense.

To resume the case: Mr. Grönberg tested positive at the out-of competition test carried out by WADA prior to the World Championships in Beijing for Diuretics. This is not contested by Mr. Grönberg who has been prescribed these medications for 100% medical reasons.

The FITA Medical Committee as well as the Swedish Sports Council is in agreement that Mr. Grönberg needs the products he was taking for a chronicle medical treatment.

The reason that this is a positive case is that Mr. Gronberg nor the Swedish Archery Association complied with the mandatory request for exemption as foreseen in Art 1.10 of Appendix 4 of the FITA C&R Book. Mr. Grönberg was not aware of this rule nor his team management. Mr. Grönberg even showed his medical certificate to the judges during the equipment inspection thinking that this was sufficient. In conclusion the Swedish Archery Association and the archer were not aware of the applicable rules.

It is for this reason that a sanction has been imposed by the Swedish Archery Association since there has been a violation of the FITA Doping rules. However because of the fact that the violation was based on lack of knowledge of the rules and outside of the will of the archer concerned a reduced sanction has been imposed.

However the case clearly highlights that the National Federations and the Team Members have to take their responsibility in the case and that most likely next time the sanction imposed will be a sanction of 2 years as foreseen in article 12.2.1.2"

The President opens the meeting at 08.30 by welcoming the new council members and thanking Mr. Wang for the organisation of the World Championships in Beijing. He points out the fact that we have a big and important agenda, including the 2003 World Championships attribution, the discussion on Laws and By-Laws and a meeting with the chairman of the committees.

1. Approval of the Agenda

The agenda is approved after the above clarification.

2. 2004 Athens Olympics presented by ATHOC

A presentation was given by Mr. Makis Assimakopoulos, General Manager Sports.

The preparation of the Games is improving much faster than in the past and the meeting with the Co-ordination Committee was successful. The company has 800 employees at present time and should have about 6000 in the future.

The new metro lines should be ready by the end of 2003 as well as the motorway, which will change the problem of transportation. There is also a rail project.

The accommodation is a challenge: the infrastructure is not settled yet and many hotels are outside Athens.

Venues: 37 venues

There are 3 different complexes for the games and the motorway will connect them together.

A training park will be available for all sports across the Olympic village. Many independent training venues are already available in Athens.

Test events: 36 tests will be organised between spring 2003 and spring 2004.

15 events for the outdoor sports will be organised in August 2003. All venues will be tested officially before the Olympics.

The archery venue will be very nice and is considered the venue of the Olympics. It will be very important to fill up the stadium, in order not to have a bad image on TV. The archers will not be shooting the first day of the Olympics.

3. Presentation by C&R on laws & by-laws and procedures to follow in relation to the by-laws that will be discussed in council.

Mr. Klaus Schulz, Chairman of C&R Committee reports on the work done from last Congress.

The decision taken at Congress is historical and in line with the FITA philosophy. This is a work between the committees, the Council and Congress. The new book will be printed in a loose-bind format in order to update it easily and will also be available on CD format. All the laws and by-laws will be on the same page, with a different writing – by-laws in italic.

The following procedure is adopted for By-laws

Procedure on By-laws

- Suggestions for By-laws or changes in By-laws, including deletions, ("Suggested By-laws") may be submitted to the Secretary General by Member Associations, Continental Associations, the President, the Council, or the Permanent Committees from within their respective terms of reference.
- 2. The Secretary General shall refer all Suggestions for By-laws to the relevant Permanent Committees for review and recommendation.
- 3. The Permanent Committees shall submit their responses to the Secretary General within 45 days of receipt of the Suggested By-laws.
- 4. The Secretary General shall distribute the Suggested By-laws with the committee's recommendations to the Constitution & Rules Committee to verify:
 - That the submitted Suggested By-laws are determined as By-laws, and
 - The Permanent Committee's recommendation is consistent with the existing FITA Laws & By-Laws
- 5. The Constitution & Rules Committee will respond to the Secretary General, within 30 days of receipt of the report from the Permanent Committee, with its recommendations on the report's compliance with the conditions of 4 above.
- 6. The Executive Committee will decide if it is necessary to put the Suggested By-laws to a mail vote or discuss and vote on the Suggested By-law at the next Council Meeting. If a mail vote is decided to be necessary, Council will make its decision using the majorities required by the FITA constitution within 14 days of receipt, unless Council decides that discussion at its next meeting is required.
- 7. The Secretary General will publish the Suggested By-laws (if approved) with its effective start date within 30 days of the decision.
- 8. Where Council does not approve the Suggested By-law, the Council will send its opinion to the presenter.
- 9. Written requests to vote on a specific By-law in Congress may be submitted to the Secretary General by Member Associations, Continental Associations, the President or the Council. This request must be submitted at least 30 days prior to the publication of the final Congress papers.
- 10. Congress will confirm or reject the new By-laws at its next session.
- 11. All By-laws will be voted on in Congress en bloc except for those noted in 9 above.
- 12. Where Congress rejects a Council decision on a By-law, the original situation is reinstated.

The President and Council Members thank Klaus Schulz and his committee as well as Tom Dielen for their excellent work done on the By-laws.

4. Preparation of the joint meeting with chairman of the Permanent committees

Chairmen of permanent committee will have the possibility to speak about their future, their needs and give their comments. Council should first agree on their planned activities plan and then approve the necessary budget.

5. Attribution of 2003 World Outdoor Championships

Lynne Evans, Vice-President welcomes the presenters of the bids.

- Presentation by Polish Archery Federation. The presentation is done by the Secretary General of Polish Archery Federation Mr. Janiszewski and Mr. Kowalczyk, Sports Director in Warsaw (and the chief of mission for Salt Lake City).
- Presentation by NAA: The presentation is done by Mr. Jay Kriegel.
- Presentation by Turkish Archery Association: Mr. Ugur Erdener on behalf of Turkey. The Turkish Archery Federation withdraws its candidature.

The following procedure is adopted for the voting

A council member coming from the same country as the "Bid country" will not have the right of vote and will be asked to leave the room during the secret ballot. If there is a tie, discussion will continue and a second round of voting will be held.

Evaluation of the bids:

Polish Archery Federation:

The financial side is the key point and needs some clarification. The budget is too low and needs to be adapted. We don't have much information on the Media side.

National Archery Association:

All the facilities will be temporarily based. There is no drainage on the field. Transportation: there will be many train and buses, but the archers will need to change several times with their equipment for the ones staying downtown.. Accommodation: 300 persons can be accommodated in the students facilities next to the field. Downtown rooms are expensive.

As a result of the 1st Round vote, the 2003 World Outdoor Championships will be allocated to: New York City.

6. Meeting with chairman of the committees to discuss Committee Activities and Budget of the committees.

- Target Archery Committee

Ms Zhang Xiuzhi joins the committee and Mr. Morten Willman left the committee. A committee meeting needs to be planned as soon as possible, in order to be ready for the edition of the new rule book. Another meeting could take place during the World Junior Championships in Nymburg. They also would like to edit a leaflet for the new club round.

- Field Archery Committee

The goal of the committee is to simplify the rules and make the sport more spectacular. The committee will meet once next year in Canberra. They will continue their work on the different books and further develop their participation on the FITA website. EMAU tried to organise a FIELD archery seminar for the 2nd time in a row but also for the 2nd time was cancelled due to a lack of interest.

- Constitution & Rules Committee

During its meeting in Lausanne, the committee did not have time to review the book entirely and therefore will need to meet one more time to finish the preparation of the new rule book. The wording will be simplified as requested by Congress. The new edition should be ready for the 1st April 2002. Special thanks to Tom Dielen for his help.

- Judge Committee :

Their goal is to have a group of high level international judges. 2 judge training seminars are planned. The committee will reissue the judge guide book and continue to issue the Judge Newsletter but the editing and follow-up will be now done by the Judge Committee..

The Chairman of the judges committee stresses the importance of the judge observer but also states that the judge's observer must not automatically be a judge, but somebody involved in judging. An Ad-Hoc Committee has been created to study the role and appointment of the judge observer for the future. IBU judge committee should work with the FITA judge committee for what concerns Archery Biathlon

- Medical committee

The main goals are still to prevent doping and injuries in archery especially for young archers. It would be good to have a doctor on each continent and for this reason Carole Hicks has been asked to find a "liaison" for Oceania. The problem of the injuries should be discussed between all continents in order to find out the reasons of those injuries and therefore avoid them by giving the correct training to the young archers. Doping is not a huge problem in archery but still exists. The problems that occurred are more due to the lack of information of the archers and doctors than as a result of intended cheating. The committee will meet in Lausanne in the 1 st trimester.

- Development and Technical Assistance Committee

Another meeting with the Continental Presidents is planned for next year, due to the success of the first one held in Lausanne. Many missions (i.e. Egypt) had to be postponed due to political problems. The development of archery project for juniors and at school is important. The Greek archers need a big support in order to be ready for the Olympics and will need our financial help.

- Coaches committee

The edition of the coaching manual takes time. It will be published in English. A coaches conductor seminar will be organised when the manual will be ready. The training tips on the FITA website are very popular now. A code of ethic for coaches will be published after the manual.

Competitor: FITA has not received any report from the chairman of this committee. The athletes should elect the members of the competitor committee. Mr. Willem Trienekens will do some suggestions to help the chairman of this committee.

Special thanks go to Pascal Colmaire for his involvement and help to several committees.

The objectives and plans for the committees have been accepted for the next year.

7. Approval of the Minutes of the last Council Meeting, September Beijing

Minutes are approved.

8. Items arising from the Minutes

- The European Indoor Championships will take place in Ankara.
- The relations with IPC are getting difficult. Our President should speak with the IPC's President during the Games in Salt Lake City.
- The opinions on the fact to hold the Congress before the Championships are divided.

For the people involved with a team, it is not easy to be present at the Congress before the Championships and it would be better to be with the team for the preparation. For the preparation of the congress it is much easier to host it before than after.

The best solution would be to separate the Congress and the Championships like many other federations but this is not yet possible.

10. IBU/FITA - Archery Biathlon

2 meetings have been held this year and several events will be organised. A letter has been signed by James Easton and Anders Besseberg which is send to all FITA and IBU Members. A letter should also be sent to the Olympic Committees and the Ministry of sports. The budget for next season is about USD 150'000 from IBU. Francesco Civarollo has proposed to give prizes to the best competitors in the archery part of the competition to show FITA's involvement in this sport. FITA must help the archers. For the first time, IBU will report the event on TV. Their project is to show this sport on Eurosport. FITA will give them a financial support of 10000 US\$ for achieving this educational video.

The President thanks Justyna Chmielewska for her contribution in the development of the relation with IBU & Ski-Archery.

11. Internet

As per the statistics there is a growing public for our website. The host site will be changed to a more powerful server. We will investigate the possibility of advertising on our page, but that means that the Olympic Rings will have to be removed. With a new service offered by Kpn Qwest, each council member will be able to check the website when travelling. Everybody will also have a private address, i.e. xxx@archery.org.

We have been working with Sportcal to put together all info about archers, events, results, ...etc in a database. A calendar will also be available and each MAS will be able to insert its own tournament list.

12. World Ranking List Calendar

The tournaments as were proposed were accepted. Council accepted to name all events "Grand Prix" events and to name the events per continent a "Tour". The continental associations will be asked to inform their members that the word "Grand Prix" is reserved for Grand Prix Events.

13. Attribution of Responsibilities to Council Members – appointment of one Vice-President to be member of the Executive Committee

A new list will be done in regards to the attribution of responsibilities to the Council members by the next council meeting

Lynne Evans is proposed and appointed as the Vice President to be member of the Executive Committee. In this appointment Council also decided that in principle there will be a rotation on annual basis between the Vice Presidents.

14. Assignment of Technical Delegates

During the Outdoor Championships, only one Technical Delegate is not enough, two would be able to give a better service to the organisers. It is suggested that as mentioned during the last Council, the Chairman of Jury of Appeal would be also elected at this stage. Pascal Colmaire has been appointed as 2nd Technical Delegate for Athens since we need someone who can travel frequently to Athens and stay on site during several weeks.

For the other positions Council has suggested names and the Executive Committee will decide after the nominated people have been asked if they would be willing to serve.

The proposal to have 3DI as an Associate International Federation has been accepted. The Executive Committee has to finalise the co-operative agreement with 3DI. A team 3D championship is the goal.

d) Archery Festival

A workgroup has been established consisting of Francis Buggenhout, Morten Wilman and Raoul Theeuws as chairman. There will be a test in 2002 or 2003 in Porec. Julien Declerc from Belgium will also help.

e) FITA @70

The celebration will finish in one month, but the results is good. The logo turned out to be a success and everyone involved has been thanked.

f) Ad Hoc Audit committee.

There is still not enough candidates. Mr. David Sheratt will be contacted.

g) It is decided that the ad-hoc committees should have a "life" time limit otherwise they should become a permanent committee. This could be 2 years, or less, depending on the work they have to accomplish. In terms of budget, there should be only one for all the ad hoc committees. A complete check will be done by the Executive Director on the status of all the ad hoc committees.

h) Protocol officer

Lynne Evans has been appointed as such. She will work with Tom Dielen to come up with some suitable gifts for certain special occasions.

i) History of Archery Book

The writer passed away last year. We need to find a new person with good writing skills. Lynne Evans proposed a deadline for the new printing at the occasion of the 75th Anniversary.

j) Organisers Manual

FITA wants to do a new format, split into 3 part: Competition management, planning and organisation and venue management. We will use some work out of manuals issued by other federations.

A work group will be created: Terry Reilly, Raoul Theeuws and Tom Dielen will be in charge of parts 2 and 3 and Pascal Colmaire of part 1. Starting the work at the beginning of next year and it should be ready in August.

k) TV

We have done a successful work with D. Curchod. The agreement with EBU has been discussed. EBU will distribute both the news and the highlights.

- What are the services offered to honorary officers? They can attend Congress and speak to it and also attend the FITA World Championships with a VIP accreditation. No expenses will be paid. They also receive all official FITA publications.
- m) Future Championships FITA will handle the entry and accreditation. The deadlines will be strictly followed.

- n) Guideline on director of shooting is in the process of being produced by Skip Phillips. This will be integrated in the organisers manual.
- o) Council decides to keep the name of the new rule book as it is, as well as the Committee name
- p) Terminology to be used for laws & by-laws in terms of motions & amendments For laws: motions on laws, amendments on laws For By-laws: motion on a by-law, amendment to a by-law
- q) Council members are requested to inform the FITA office if they see a commercial or publicity using archery as a tool for promoting a product. More and more archery is used but there could come a saturation.
- r) A presentation was given on the Management Seminar for our Member Associations

We will do a seminar for our member associations. This will be held in Nymburg. TSE Consulting will conduct the seminar in co-operation with FITA to create awareness of the FITA goals and find a solution on how to achieve the goals. The seminar will be conducted in English, but questions can be asked in other languages. The manual, which will be produced, will be copyrighted to FITA.
