



C&R RULE INTREPRETATIONS

Questions asked by

Allan R. (Al) Wills, Vice President International FEDERATION OF CANADIAN ARCHERS INC.

<u>Practice for Indoor Rounds</u>: in Canada, we sometimes shoot 18m FITAs in two flights - Flight 1 and Flight 2. There are two formats used as follows:

- Format #1 Flight 1 shoots 30 arrows, takes a short break then shoots 30 arrows. Then Flight 2 does the same thing.
- Format #2 Flight 1 shoots 30 arrows. Then Flight 2 shoots 30 arrows. Then Flight 1 shoots 30 arrows. Then Flight 2 shoots 30 arrows.

There are currently many different practice routines in use across the country for these formats and we are interested in standardizing within FITA rules.

- (1) What is the appropriate practice routine for each of these above formats?
- (2) Is there any requirement that the archers be allowed to practice on their own target butts?
- (3) Would it be OK to have a Canadian rule that requires organizers to allow archers to practice on their own butts for at least two ends?
- (4) In the case of Format 2, is it permissible for the archers returning to shoot their second 30 arrows to practice before doing so?

Answer by C&R

As to the questions asked we are unanimous that only format 1 is normally practised in FITA since the round consists of 60 arrows.

Format 2 raises the question whether records can be shot at all. Format 2 is two rounds of 30 arrows, and the 30 arrow round does not exist according to FITA rules 4.5.2 and 5.3.1.

- Article 3.19 refers to championships. For national purposes, you can adjust practice to the organizers and competitors. The archers do have a right to practice arrows, however. Format 2 is not foreseen at all. Only one practice session is foreseen for 60 arrows.
- Q2 Practice just before the competition should take place on the target assigned to the competitor (there is no explicit rule, but this is common sense and common practice).
- Q3 Yes, the answer follows from the introductory remark.
- Q4 Format 2 is not according to what is practised in FITA and would not be a FITA event, practice arrows before the second round of 30 arrows would break FITA rules but could be accepted if you introduce the event as a national Canadian event. Why break away from FITA practice, however?

Archers can warm up between rounds, if organisers have a warm up Field of Play at a different location (hall or section of hall). This facility can be provided at the option of the Organising Committee.

Anti-Doping News

COURT OF ARBITRATION FOR SPORT 2003/A/479 VAN LAMOEN GOMEZ C/ FITA

CAS has recently imposed a one-year ineligibility sanction, commencing on 12th September 2002, in the appeal launched against FITA by the Chilean athlete Denisse Van Lamoen. Ms Van Lamoen, who was tested positive with etilamphetamine at a doping control during the ODESUR Games in Brazil in August 2002, is therefore eligible to compete since 13th September 2003.

FITA is pleased to see that the offending substance has been recognized in the category of heavy stimulants. Being strongly committed in the fight against doping, FITA regrets that the current process within its Board of Justice cannot give the means to impose the sanction related to the gravity of the anti-doping violation. FITA consequently takes note that only the initial sanction of one year suspension from the National Federation of the athlete could be enforced.

These issues will be resolved when the new FITA anti-doping rules come into effect as of 1st April 2004, as a consequence of the adoption of the World Anti-Doping Code by FITA Congress in July 2003 in New York (USA).

ADVERSE ANALYTICAL FINDINGS, PENDING CASES, DECISIONS MADE BY RELEVANT AUTHORITIES WITHIN MEMBERS ASSOCIATIONS (AS OF 25TH NOVEMBER 2003)

Chile: see above

Belgium: two cases respectively considered by the French-speaking Archery League and the

Disciplinary Commission of the Flemish Community have lead to no sanctions.

NEW FITA ANTI-DOPING RULES

As already mentioned in a former FITA Info issue, FITA Council is just about to adopt new anti-doping rules in accordance with the World Anti-Doping Code, which has been adopted by the New York Congress in July 2003.

These new rules will come into effect as of 1st April 2004. However, Members Associations will have until 13th August 2004, when the Athens Olympic Games are open, to make their own rules in conformity with the FITA ones.

As soon as the final rules are adopted by FITA Council, they will be circulated amongst Member Associations, and as of January 2004, FITA will be ready to assist MAs on any questions they may have on how to enforce these new rules. Please note that the 2004 list of prohibited substances and methods is already available on the World Anti-Doping Agency's website at www.wada-ama.org.

THE FIGHT AGAINST DOPING - PRACTICAL CASES

The example of current cases together with the difficulties encountered to obtain information from certain MAs prompt FITA to draw its Members' attention to some points within the new rules. Here are some examples:

T/E ratio greater than 6:

Need for a further investigation in order to determine whether the ratio is due to a physiological or pathological condition. If previous tests are not available, the athlete shall undergo an

endocrine investigation or be tested unannounced at least three times within a three-month period (this already exists in current rules).

- Information to FITA:

Results of all doping controls shall be reported to FITA <u>within 14 days</u> of the conclusions of the Member Association's results management process. If the completion of the hearing is delayed <u>beyond three months</u> following completion of the results management process, <u>FITA may elect to bring the case directly before the FITA Anti-Doping Panel</u> at the responsibility and at the expense of the Member Association.

Members Associations shall keep FITA and WADA fully apprised as to the statutes of pending cases and the results of all hearings.

- Finally, and this is nothing new, FITA reminds its Members of the urgent need to make their athletes (and not only the ones competing at international level), trainers, coaches, etc... fully aware of the therapeutic use exemptions processes. FITA has always recognized to athletes the right to take care of themselves, but those who use medically prescribed prohibited substances may be subject to sanctions unless they have previously obtained a therapeutic use exemption.

Questions & Answers

OLYMPIC GAMES

How does one go about competing or "trying out" in the Olympic Games?

There are generally a maximum number of athletes allowed in any one sport. In Archery it is 64 Women and 64 Men. Countries "win" positions in the Olympic Games at the World Championships before the Games and by a series of events held in each Continent. A small number of places are allocated by the IOC and FITA (jointly) to assist developing nations. Each country has an internal qualifying process for each sport and then the National Olympic Committee of each country decides on how many athletes to send in each sport.

For archery, you must belong to the Archery Association in your country of residence (with passport) that is affiliated to FITA. The list of FITA Member Associations is displayed on our website: www.archery.org.
