## **WORLD RECORD**



#### PERFECT SCORE FOR CHOI WON JONG

FITA congratulates CHOI Won Jong who smashed up the World Record for 12-Arrow Final Match (Men Recurve) with a perfect score of 120 points with 0 X's (previous record: 119).

The Korean archer shot this record at the 86th National Sports Festival Archery Tournament in Ulsan (Korea) on 18 October, 2005.

The score can now only be equaled but it can still be improved by shooting more X's.

#### **DECISIONS OF FITA COUNCIL**

The full minutes will be published in the next FITA Information.

#### Main decisions:

- Confirmation by Council of Tom Dielen as Executive Director. He will have the dual role of Secretary General and Executive Director.

- Appointment of FITA Event Manager as permanent FITA Technical Delegate. FITA Council once more expressed its entire confidence in the FITA staff and its Event Manager as the permanent FITA Technical Delegate for FITA World Championships.

Only for events for which more than one technical delegate is necessary such as Olympic Games, FISU events, World Games or others, FITA will in the future appoint a specific technical delegate. For this reason the following people were appointed:

- o Olympic Games: Juan Carlos Holgado and Kotaro Hata
- o World University Championships 2006: Jean Pierre Gabarret; Juan Carlos Holgado is the FISU Delegate for this event
- o World Games 2009: James Larven
- o Universiade 2009: Alojz Mauser; Juan Carlos Holgado is the FISU Delegate for this event

- World Indoor Championships 2007 were awarded to Izmir, Turkey after the withdrawal of Luxembourg.

- World Field Championships for 2008 were awarded to Rhondda Valley, Great Britain pending an inspection visit.

- The Appeal fee for FITA events is 50 US\$.
- The maximum number of International Judges is 80 for 2006.

- All appeals by judges in relation to their re-accreditation as FITA international Judges were rejected.

#### **INFORMATION ON PRIZE MONEY IN FITA WORLD CUP TOURNAMENTS**

FITA recommends all Member Association who have archers participating in the World Cup to make clear contracts with their athletes in relation to the possible prize money that they can gain. Since this is the first time that archers will be able to gain a substantive amount of money and since member associations are most likely to assist the archers to go to these events, it is in everyone's interest to make clear agreements beforehand.

Furthermore we are aware that in certain countries it could be in the benefit of the archer concerned that the money is transferred to the archer in form of a scholarship. It is also important that you check with fiscal authorities so your archers or your member association are not faced with serious financial or tax issues as a result of winning prize money.

Unless the archer tell us otherwise FITA will transfer the money to the archer after receiving a form which will contain the bank details provided by the archer.

#### **REVOCATION OF LICENCE**

The Association Suisse de Tir à l'arc (ASTA) informs that Mr. Raymond CHABLAIS from Switzerland is not in possession of the ASTA licence on the international territory. He was sanctioned by ASTA and FITA for cheating at the 2004 World Championships in Plitvice, Croatia.

National federations close to Switzerland are requested to inform all clubs and organisers that Mr. CHABLAIS is not allowed to compete in championships and tournaments, because he is not a member of ASTA any more.

## DEVELOPMENT

#### **NEW FITA STRATEGIES IN ARCHERY DEVELOPMENT**

Until now on, for developing archery, FITA has mainly organized starting missions and level 1 courses, with the objective to get new active member associations in a near future. New development strategies and projects are under preparation. Below is an overlook at this news.

FITA is now considering some new programs with an effect at an intermediate or long term effect, especially in assisting some countries that are in the middle of the elite pyramid to reach a higher level and to increase their chance to compete in the future Continental and World Championships as well as the Olympic Games.

For instance, FITA is currently actively working on a project of an archery centre in the Middle East. A site will be selected very soon and negotiations with a world class coach have been introduced.

A pragmatic program for increasing the number of women in our sport should be experimented next year with some Member Associations. More information by the end of this year.

Meanwhile FITA will keep striving to assist the start of archery in some countries and to help some "small" Member Associations to grow. For instance from January 2006 FITA will duplicate the current experience of a Development Officer in Oceania. The duplication will be implemented in the West Africa. Next FITA Info should provide the final arrangements for implementing this project.

## **ANTI-DOPING**

#### **INCORPORATION OF FITA ANTI-DOPING RULES**

The FITA Rules and the World Anti Doping Code do not allow for a suspensive effect of sanctions. All sanctions related to doping violations have to be effective sanctions.

We also remind all member associations that the member associations rules for doping have to be compatible with FITA rules and the World Anti Doping Code. Any legal barrier that might have existed in certain countries with national legislation should disappear with the adoption of the Anti Doping convention by UNESCO on the 19th October 2005.

Since FITA will have to start to prepare for the monitoring of its implementation of the Code by WADA in 2006, we will be checking that each member association has properly implemented the Code. We remind all member associations of the following article of the FITA Rule Book

#### 14.1 Incorporation of FITA Anti-Doping Rules

All Member Associations shall comply with these Anti-Doping Rules. These Anti-Doping Rules shall also be incorporated either directly or by reference into each Member Associations Rules. All Member Associations shall include in their regula tions the procedural rules necessary to effectively implement these Anti-Doping Rules. Each Member Association shall obtain the written acknowledgement and agreement, in the form attached as Article 20, of all National Team Member Athletes

subject to Doping Control and Athlete Support Personnel for such Athletes. Notwithstanding whether or not the required form has been signed, the Rules of each Member Association shall specifically provide that all Athletes, Athlete Support Personnel and other Persons under the jurisdiction of the Member Association shall be bound by these Anti-Doping Rules.

#### **BLIND ARCHERY RECOGNIZED BY IPC**

For the first time ten or so blind archers competed in a demonstration event hoping that blind archery would become a Paralympic discipline. A big step forward has been achieved with the International Paralympic Committee (IPC) deciding during its Congress held in Massa-Carrara to include blind archery in its future events. Blind archers use the same material as able archers, but it is the aiming technique that is different.

## **2006 EVENTS**

#### FITA LAUNCHES A NEW WORLD CUP

FITA is proud to communicate the beginning of an exciting era for all archers and fans. A new World Cup will be running in 2006 for Outdoor Target. Individual Men and Women will be competing in Compound or Recurve.

The World Cup consists of 4 selected events and a Grand Final in Merida (MEX) on October 22. This World Cup Final in Mexico will take place at a splendid location, the feet of the Maya pyramids Chichen-Itza. It will follow the World Junior Championships in October.

FITA will provide an attractive Prize Money for the Final.

The top 4 archers in each category will qualify for the Final based on their World Cup points earned during the 4 stages of the 2006 circuit only. These events are:

- Porec, Croatia, May 10-13
- Antalya, Turkey, June 7-10
- San Salvador, El Salvador, June 21 25
- Asia, place to be confirmed, September 2006

Prize Money will also be given in each of these qualifying stages to the top 3 archers.

A new commercial strategy is developed around this World Cup circuit with an attractive program for sponsors and a broad media exposure. All the qualifying events as well as the Final will be covered by the FITA TV production team and the FITA website. This will extend the planned TV distribution of the Field World Championships in Göteborg and the European Outdoor Championships in Athens.

With the 2006 Archery World Cup, FITA wants to create an exciting competition that will enhance the international calendar with more top events. FITA is looking forward to raising the interest of the fans, the media, the sponsors and, of course, of the archers!

#### WORLD JUNIOR CHAMPIONSHIPS + WORLD CUP FINAL

The World Junior Championships will be hosted from the 15-21st October 2006 in Yucatan Mexico. The initial program is the following:

15th October: Opening ceremony
16th October: Long Distances
17th October: Short Distances
18th October: Cadet Individual Eliminations
19th October: Junior Individual Eliminations
20th October: Team Round (Eliminations + Finals)
21st October: Individual Finals (1/2+Medals) at Chichen-Itza
22nd October: World Cup Final (elite) at Chichen-Itza

The FITA Secretary General and the FITA Event Manager who is also the Technical Delegate for this event, visited the host city Merida and the Organising Committee.

### **FITA INFO 10/05**

Despite the Hurricane Wilma, the visit was very successful and resulted in the signing of the Organisers Agreement. The organising committee will be headed by Mr. Cesar Gonzalez of the Institute of Sports in Yucatan.

The transportation of the FITA Judges appointed for this event will be paid by the organising committee.

The Individual finals will be held next to the ancient Maya Pyramids and this will be an unforgettable experience for the juniors. This will also be the background for the World Cup Final.

The organising committee is looking into making more kinds of hotel available at different levels from the bid presented in Congress so the member associations can budget the bid documents as maximum prices. There will be at the request of FITA only a closing party and not a closing banquet. This will also be the recommendation to all future organisers of FITA events.

USA Rick Stonebraker had the privilege of teaching an instructors seminar in Dubai on October 13-15. The Dubai Archery Club sponsored him to certify other instructors. They have an excellent archery range on the grounds of the Dubai Country Club. They have introduced many people to the sport with their energy, enthusiasm and are a positive influence in the development of archery in the United Arab Emirates.

The students came from the local club and three resorts in the area. The nationalities attending included: South African, English, Scottish, French, Spanish, Pakistan, Indian, Moroccan, Iranian and two Texans. The mid afternoon temperatures averaged 42C with a peak of 47C. Summer temperatures there can be a blistering 52C!

For each of the seven levels included in the FITA Beginners Awards Program, this illustrated manual describes in details what the beginners should do, demonstrate and know:

- the minimum required score;
- the archery skills;
- the knowledge and/or know-how's.

The Entry Level Coaches will find in the FITA Beginner's Manual the information to properly evaluate their students, including the specific evaluation form for each level.

In short, this manual is a compilation of the curriculums of the seven levels of the FITA Beginners Awards Program. This manual is also available in French and a Spanish version is under consideration.

#### Bylaws decisions approved by FITA Council on 8 October 2005

The following bylaws decisions have been made by FITA Council on 8 October 2005. <u>These bylaws will all come into effect as of 1 April 2006.</u>

Additions to existing articles or new articles are underlined.

#### Book 1, Appendix 5, Article 7.3: Anti-Doping rules – Results Management

7.3 Results Management for Tests initiated by Member Associations

Results management conducted by Member Associations shall be consistent with the general principles for effective and fair results management which underlie the detailed provisions set forth in Article 7.1. Results of all <u>Doping Controls</u> <u>Adverse Analytical Findings</u> including information on the athlete concerned as per Art. 14.3 of these rules shall be reported to FITA within 14 days of the conclusion of the Member Association's results management process reception of the laboratory report by the Member Association. Member Associations shall keep FITA fully apprised as to the status of the results management process and its conclusions (including a planned date of the hearing) in all pending cases. Any apparent anti-doping rule violation..... (the rest remains unchanged).

#### Book 1, Appendix 5, Article 14.3: Anti-Doping rules – Results Management

14.3 Doping Control Information Clearing House

When a Member Association has received an Adverse Analytical Finding on one of its Athletes it shall report the following information to FITA and WADA within four teen (14) days of the process described in Article 7.1.2 and 7.1.3: reception of the related laboratory report: the Athlete's name, gender, date of birth, country, sport and discipline within the sport, whether the test was In-Competition or Out-of-Competition, the date of Sample collection and the analytical result reported by the laboratory. ..... (the rest remains unchanged).

#### Book 1, Appendix 5, Article 20 and Book 1 Appendix 13: FITA Anti-Doping Agreement

New item 3

3. <u>I consent and agree to the creation of my profile in WADA Doping Control Clearing House (ADAMS) and/or any other authorized National Anti-Doping Organisations (NADOs) similar system under FITA's agreement for the sharing of information, and to the entry on my doping control and Therapeutic Use Exemptions related data in such systems.</u>

#### Book 2, Article 7.1.1.8 (also Book 3, as applicable): Range layout

7.1.1.8 There will be a point marked on the shooting line directly opposite each target butt. There will also be a number corresponding to that target butt elose to between 1 and 2 meters in front of the shooting line..... (*the rest remains unchanged*).

### **FITA INFO 10/05**

#### Book 2, Article 7.2.4.1 (also Book 3, as applicable): Time Control Equipment

7.2.4.1 In the event of any <u>a small</u> discrepancy between the acoustic and the visual time control equipment, the acoustic time control equipment will take precedence.

#### Book 2, Article 7.2.5.14: Miscellaneous equipment

7.2.5.14 On <u>shooting fields other than the Final Field or Finals area of the main field, a</u> sufficient numbers of **chairs or benches** placed behind the waiting line for all athletes, Team Captains, <u>coaches</u> and other officials.

The chairs for Judges, with some shelter from the weather, should be placed at appropriate places along the waiting line for the qualification and elimination round fields.

(For Olympic Games and World Championships finals field, see Book 1, Chapter 3, Art. 3.23)

#### Book 2, Article 7.6.1.5-7: Scoring at Olympic Games

For Olympic Games only, this article reads as follows:

In the <u>Elimination and Finals of the</u> Olympic Round, Elimination and Finals Rounds, the value of the arrows will be determined <u>and recorded</u> by the Spotter and the Scorer in the order they are shot. These unofficial recorded values will be checked <del>and changed if required</del> by the <u>athlete's agent</u> by the <u>Target Judge if required</u> when the official scoring takes place at the target. The agent of the opposing athlete/team will check the value of close arrows on the opponents targets. In case of disagreement <u>between the two archers agents</u> the assigned Target Judge makes the final decision. To verify the score the Target Judge calls the arrow scores in descending order. The Scorer and the athlete's agent check the correctness of the <u>arrow</u> scores <u>in the target</u> on the scorecards. <u>Target Judge must signed any changed score</u>.

#### Book 2, Article 7.6.2.9 new : Scoring

7.6.2.9 A miss shall be recorded as "M" in the scorecard.

#### Book 2, Article 7.6.4.1 new (also Book 3 as applicable): Scoring:

For Elimination Rounds, scorecards shall be signed by the two athletes in the match, denoting that both athletes agree with the value of each arrow, the total sum, the number of X's and the result of the match.

#### Book 2, Article 7.10.1.2 (also Book 3, as applicable): Questions and disputes

7.10.1.2 A mistake on the scorecard <u>discovered may be corrected</u> before the arrows are drawn may be corrected, provided that all the athletes on the on the target agree on the <u>correction</u>, <u>but</u> <u>t</u> he correction must be witnessed and initialled by <del>one of the Judges</del> before the arrows are drawn all the athletes on the target... (the rest remains unchanged).
