## **Launch of World Archery**

On the occasion of the Archery World Cup stage in Antalya, Turkey early June, FITA officially launched its new brand and logo – World Archery.

World Archery is a forward-focused brand representing the sport of archery to both sports enthusiasts and the worldwide market beyond the archery family. The federation wants the sport of archery to be in the forefront—a global consumer brand, that promotes archery at every level with enthusiasm and passion.

Represented by the new, dynamic logo, the World Archery brand unifies all of the activities, events, and members of the federation under one brand name to be centrally promoted by FITA and its Continental Associations. The FITA entity and logo remain valid as the producer of this brand. The World Archery logo will be used at upcoming events such as the Youth, Para-Archery and World Archery Championships.



The vibrant colours, fundamental characteristic of the World Archery logo, reflect its bright and modern attitude while building allimportant recognition. Following best business practices from the corporate world, FITA understands that the immense value of strong branding cannot be over emphasized, especially today. The new brand-Archery—was developed with the strategic of cooperation Consulting; former Saatchi and Saatchi designer Nick DARKE designed the logo.

#### **New Compound Format Test**

The working group of the Archery World Plan on the differentiation between compound and recurve organised its last test prior to 2009 FITA Congress. The test was held at the National Training Centre of Papendal in the Netherlands. Two other tests were held in 2008 in Lausanne and Madrid.

The last test was mainly to finalise the size and colour pattern of the Hit/Miss target faces for the compound discipline.

Among the archers testing the system was the new world record holder for the FITA Round, Peter ELZINGA who was defeated in the final match by Rob POLMAN who just joined the 1400 club.

#### Madrid, Spain - 25 May



Mr DIELEN gave a presentation on the FITA Development Department with a focus on the Olympic Solidarity (OS) programmes from 2009 to 2012. He reminded how important it is for FITA Member Associations to receive OS funds.

Among the topics discussed at the COPARCO Congress were information about development in the Americas, reports from COPARCO President and Treasurer, information on medical and anti-doping issues, judges, continental multisite indoor competition of the Americas (MICA), new sites for World Ranking events in 2010, and continental pre-Olympic Youth Olympian spots.

#### **Committee meeting**

On 15-16 May 2009 in Regensburg, Germany, the C&R Committee held a fruitful meeting, led by its Chairman Mark MILLER.

The participants enjoyed the warm hospitality of Klaus-Dietrich SCHULZ, who kindly provided the facilities to welcome his fellow members Mark MILLER, Giuseppe CINNIRELLA and Tom DIELEN, as well as Françoise DAGOURET from the FITA Office.

Among the topics discussed were the new Rule Book structure—to be edited in March 2010—in line with the recommendations from the Archery World Plan working group on this matter, the current interpretations and FAQ requests, the Judges Guide Book review, and the Motions and Proposals to be submitted at Congress, together with their amendments.

Another meeting is scheduled for November 2009—after the Council meeting—in order implement Congress decisions in the FITA Constitution & Rules.

Peter ELZINGA (NED) set a new world record with 1419 points at an international tournament in Purmerend (NED) on Sunday 17 May 2009. The previous mark was held by Roger HOYLE (USA) with 1414 points since 2001.

ELZINGA also beat the world record at 70 metres, scoring a close to perfect 358 points (out of 360).






# INTERPRETATIONS

#### FITA CONSTITUTION AND RULES

Book 2, Articles 7.3.1.5.2 & 7.3.1.5.3 Book 3, Articles 8.3.1.5.2 & 8.3.1.5.3 Book 4, Articles 9.3.5.1.2 & 9.3.5.1.3

A question was raised by a Council Member as to which of the sight pins listed below are legal under FITA rules:



The Constitution and Rules Committee finds the question presented to be within terms of reference of the Technical Committee.

The Constitution and Rules Committee has determined that the following interpretation of the Technical Committee is not contrary to the existing rules or Congress decisions.

#### **Response from the Technical Committee:**

Regarding the overall length of the sight, the fiber optic sight pin is considered to be a separate unit which may be a max of 2cm in a straight line. The housing supporting the fiber optic pin may be a max of 2 cm in length. The housing and fiber optic sight pin are measured independently.

Therefore – all the variations illustrated above will be legal, as the fibre optic sight pin is not exceeding 2cm.


The fiber optic pin can be longer than 2 cm but must bend/curve after the 2 cm straight section.

# **INTERPRETATIONS**FITA CONSTITUTION AND RULES

## Book 4, Article 9.3.5.3.1 Book 5, Article 11.10.3.3.5.1

A question was raised by a Member Association as to whether the scope shown is legal under FITA rules for Field and 3D Archery



The Constitution and Rules Committee finds the question presented to be within terms of reference of the Technical Committee.

The Constitution and Rules Committee has determined that the following interpretation of the Technical Committee is not contrary to the existing rules or Congress decisions.

#### **Response from the Technical Committee:**

This scope is legal for all FITA disciplines including Field and 3D Archery.
