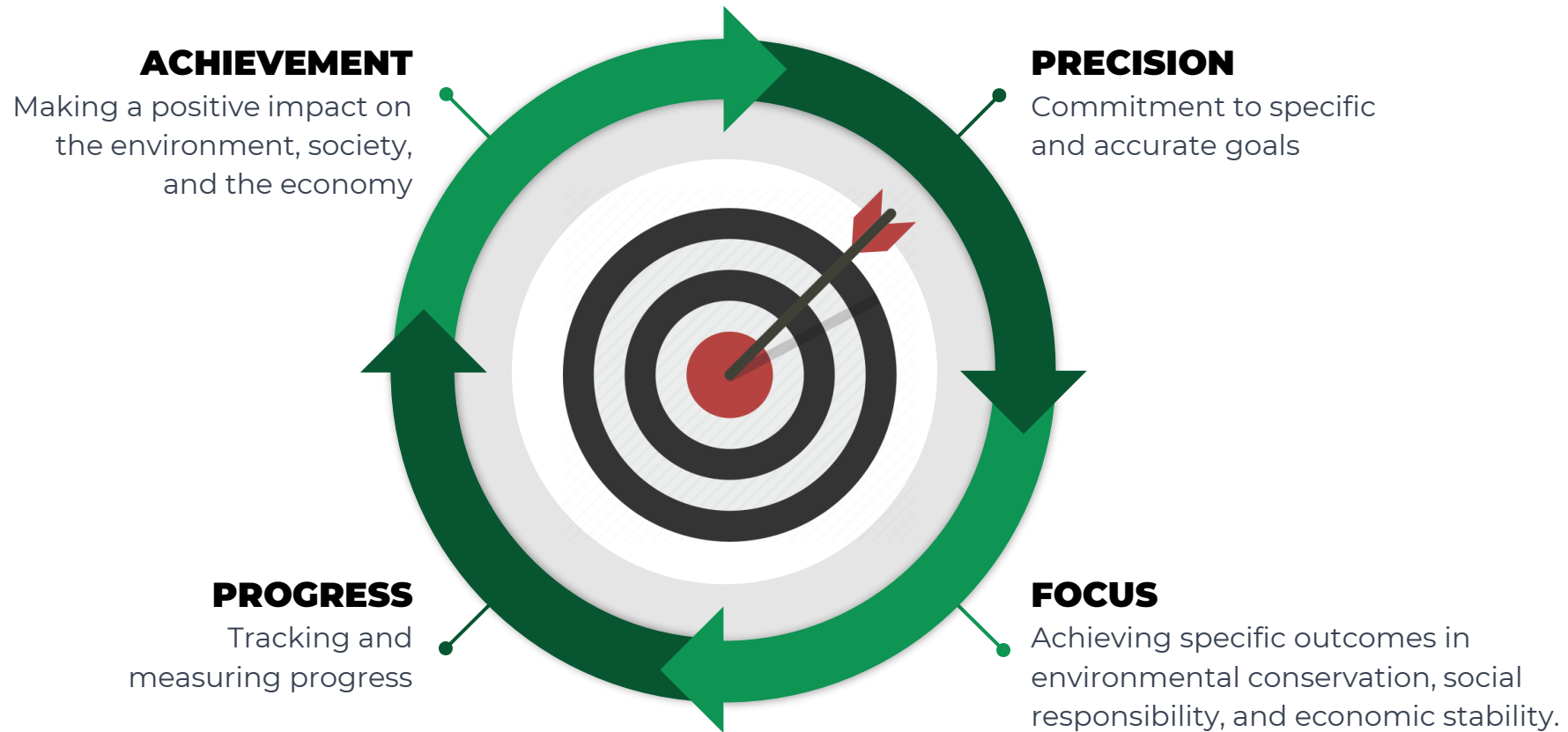

## Deadlines

**Definition:** the latest date by which something should be completed.

- Payment deadlines MUST be respected, otherwise, hotel bookings and registrations will be removed.
- Preliminary deadline is by when NUMBERS must be provided
- The period between Preliminary and final entries is when you must CONFIRM the names.
- After final entries, no ADDITION will be allowed. Only name changes.

- Only change: Option for 1/64 is removed. Cut to 64 athletes for each category. Every event.

## Bylaw 1. Timings for 3D archery - updated version

- For qualification rounds, the time limit for Field is 180 seconds and for 3D is 120 seconds.
- 3D Timings - updated version
- In Field Rounds, the time limit for individuals and teams is 120 seconds, **and for mixed team is 160 seconds;**
- In 3D Rounds, the time limit for individuals is ~~one minute~~ **90 seconds, for teams 120 seconds, and for mixed teams 160 seconds;**

Reason: This follows from the request to increase the number of arrows shot in elimination and finals – the timing must be adjusted to give time to shoot the additional arrow.

## Bylaw 2. Visually Impaired - Olympic Round

The Elimination and Final Rounds consist of:

- The Elimination Round, in which the top 104 athletes (mandatory for World Archery Championships) are seeded according to their positions in the Qualifying Round (see *Appendix 3, Book 2 - Match Play Charts*). They shoot a series of matches in groups, each match consisting of the best of five sets of three arrows.
- The Finals Round, in which the eight athletes remaining from the Elimination round shoot individual matches, each match consisting of the best of five sets of three arrows, culminating in the gold Medal match. At World Archery Championships the matches shall be shot one after the other. The athletes shall shoot alternately one arrow at a time.
- The format may be amended to fit special stadiums and locations that are very attractive for archery. It is necessary to notify Member Associations at least one year in advance of the event;

Judge Committee: The Judge Committee have indentified that the rules for the VI Olympic Round omitted the system used – i.e. Set system with 5 sets of three arrows.

## Bylaw 3. Removal of name plates

- ~~7.2.6.4 In the Olympic, Compound and the Indoor Match Round a name plate carrying the athlete's number or name in the individual events, or the official acronym of the Team, shall be displayed in front of the shooting line.~~

Reason: It represents a paper consumption of about 400 A4 pages per World Cup event, more than the double for World Championships (outdoor, para and youth)-

The information it provides to the athlete (target number progression throughout the eliminations) can be reproduced on the back number of each athlete. It requires extra LOC staff and volunteers to coordinate the proper installation and removal, and is occasionally leading to delays in rounds start time

In general, information is easily accessible either through live scoring system, screens on venue, and tablets with dedicated app for the judges.

## Bylaw 4. Classification at events (by USA)

International classification may be conducted at any event on the World Archery calendar, provided rules for a Classifier Panel set forth in the Para Archery Classifier Handbook are followed.

Comment from Para-Archery:

The Para committee asked to postpone this bylaw again. We are waiting for the new IPC Classification code and already have started to work on a new process for the classification of events for 2025. The work is done with the classifiers committee, para committee and Thomas AUBERT. We need time to build a good strategy and to measure all impacts.

## Bylaw 6. Run Archery (by FRA)

- 34.1.10 : necessary to precise that the publication of results is done, that people know the deadline to protest on it.
- 34.2.1.11.2: after experience, the additional paper face on dropdown target is very useful. Better to add in the rules that it is allowed.
- 34.2.5.8.2: following several competition, it seems that 10s is the usual time given by judges. Better is to add it as such in the rules to prevent new judges to lose time for thinking about it
- 34.2.5.9: necessary to mention that holes must be marked (and by whom)
- 34.2.5.11: during the European Cup, some athletes did some release movement which was very confusing for the archery range judge. This new text prevent this kind of situation
- 34.2.6 and penalties: necessary to clarify some points because of missing sanctions. The rule forbid some things, without the consequences.
- 34.2.7. Proposal of clarification about forbidden behaviors and following sanctions.

## Bylaw 7. Para Archery W1 Assistant

- The athlete can give directions to the assistant only for loading arrows or adjusting sight or other pieces of the athlete's equipment. ~~The assistant must remain silent during the end of shooting and not provide coaching to the athlete in any way. In particular, the assistant is forbidden to spot, or to use a scope or binoculars.~~ The assistant will act as a coach and must do so in a way that doesn't disturb the other athletes on the shooting line. There is no other coach allowed behind the shooting line. This applies throughout the event from the qualification round to the final round.

Reason: The intention of the bylaw adopted at the end of 2022 was to avoid "double coaching" which gives an advantage to teams with a larger number of staff. The outcome of this agreement at the time was to have the assistant be silent.

- The committee considered the following:
  1. If an athlete had 2 people (coach AND assistant) it could potentially give an unfair advantage to those countries who can afford to bring a greater number of staff.
  2. It was also felt this would be easier for judges as with the current situation, it is impossible for them to determine what is being discussed between assistant and archer.
- The Para Committee have fully discussed this and agreed:
- Assistants will be allowed to speak and to also give coaching instructions, but it means that athletes will not be allowed to have an additional person as a coach, for example a coach in the box..

## Bylaw 8. Para Youth competition

- 21.4 Add :

A para-archer may participate in an U21 Class in tournaments when the competition takes place up to and in the year of the athlete's 20<sup>th</sup> birthday.

...

- Add 21.8.2
- There may be 18m Para-archery events. The competition can be shot Indoor or Outdoor.
- Athletes compete in their age class as defined art 21.4.
- The distance of shooting will be 18 meters and the target faces will be:...

Reason: World Archery Americas as first presented a proposal to recognize a youth category for Para-archery.

- The strategy will be to create an indoor (short range) format that will provide a first step for starting international competition.

## Bylaw 9. Visually Impaired archers' tactile sight

There shall be a space of not less than 90 cms (35.5 inches) between each tactile stand (measured from the nearest point of each stand). The size of the tactile sight may not exceed 2 cms in any direction and shall only be in contact with the back of the athlete's hand, between the wrist and the base of the fingers. It can sit between the knuckles but not between the fingers.

- Reason: The committee agreed that allowing archers to use the area between the knuckles may help to improve more accuracy in shooting and does not impact fairness as all VI archers will have the same advantage.

## Bylaw 10. Shooting line, para archery

For all Para-Archery Events the ground shall be marked as set out in the World Archery Rules except:

- Each athlete shall be allocated a minimum of 1.25m;
- Lanes for individual events shall be a minimum of 2.50m ~~(or 3.75m)~~;
- Lanes for doubles or mixed teams' events shall be a minimum of 2.50m ~~3.75m~~.

### APPENDIX 2 - 10.1 :

- With classification panel approval, ~~W1 or ST~~ athletes with severe upper limb disability who are unable to nock their arrows safely or efficiently or adjust their sight may be allowed an assistant for this purpose.

Reason: 21.11.4: to comply with the new composition of teams (doubles instead of 3 men teams)

- APPENDIX 2: some W2 with heavy disability in upper limbs and who doesn't reach the criteria to be W1 can also be allowed to get an assistant. That is already applied and specified on the classification card. Better it to be not restrictive in the classification classes.
- (Support) The TAC view the changes as practical. We offer a general reminder to keep rules simple and avoid duplicating items.

## Bylaw 12. Bow quiver

Traditional bow: .. Including arm guard, chest protector, bow sling, finger sling, belt, back, hip or ground-quiver. ... Also permitted are limb dampeners. ~~Arrow quivers shall not be attached to the bow.~~

Reason: The Israeli Archery Association is trying to embrace and coordinate with its instinctive/traditional archers, which is a big part of its membership (around ¼). Some of World Archery's rules are considered strict and against the nature of their community, but they accept them. The ruling on bow quivers, however, is considered as a major inconvenience for them and for no apparent reason. While bow quivers are a common practice for most of the traditional community they do not add any advantage to the archers using them. Therefore the prohibition of them should be lifted to encourage the fuller integration of this community within the MA's and World Archery.

- Field & 3D Committee is not in favor of the Bylaw on bow quivers on Traditional Bows. Our primary concern is that the quiver attached to the bow may serve as (i) a weight added to the bow, which is not allowed in Traditional Bow division, and (ii) reference point(s) assisting archers in aiming/ranging.
- Field & 3D Committee also agrees with the additional comments, TEC made in relation to this topic. If this change is to be considered in the future, more detailed discussion is needed to ensure the Traditional Bow division remains a distinctive division.

## Bylaw 13. Number of officials (by SVK)

The number of officials that may be entered by a Member Association is limited. At World Championships or World Ranking Events, the number of officials will be limited to 50% of the number of athletes registered rounded up. For teams entering two or fewer athlete, can enter one Team manager and one coach.

Reason:

Many small federations send small teams consisting of 2 athletes and sometimes they have issues to with only one official to support the archer and deal with the emergency situations. This change can help athletes officials at the competition to cover different situations. for example, one coach is still with the athlete on the field while the team manager attends the TM meeting or deals with the medical situation of another athlete.

With the current rule, a small delegation comes to a situation where the archer is left on the field without support from the MA coach. All committees support this change

## Bylaw 14. Ranking 9-16 (by SVK)

- The top ~~8~~ **16** athletes (teams) shall be individually ranked.
- Athletes/teams eliminated in the ~~1/4~~ **1/8** final shall be ranked as follows: ...
- Reason:

Many federations which rely on funding from national or local governments have to submit results from competitions in order to gain funding. To stipulate final rank at least to 16th place will help to gain funding and clearly divide the final rank up to 16th place. Also, it will help to make the final rank for a competition which is used as the qualification tournament for the multisports event. For example World Championship 2021 in Yankton where in the compound category first 10 positions were awarded place to World Games.

Commment Coaches committee: It depends on the country. If we change the ones that will be 11-16 in many countries will lose funding Proposal to study with the national federations and come back to the board when we have the outcome of the study before a decision is made that can only be done after Paris anyway.

- For individuals the shoot-off should take place on the same target face type (~~A, B, C or D~~) and ~~type~~ (40cm vertical triple face, 40cm triangular triple face, 60cm face) on which athletes involved have shot in the Qualification Round. ~~If this is not possible, one or more butts shall be arranged, with a maximum of two faces each, for a maximum of two athletes per butt~~
- For individuals there shall be one athlete per target butt on neutral target butts in the middle of the field with the target face in the middle of the butt. If space is limited, then there may be two athletes per butt, with one target face for each athlete, positioned left and right on the butt.
- Reason: With the change to the compound set-up for Individual shoot-offs outdoors, it seems logical to follow the same approach for indoors with one athlete per butt. As per the current rules, we have added that if space is limited, then there may be two athletes per butt.
- We have done this through adding an additional bullet point to ensure it is clear.

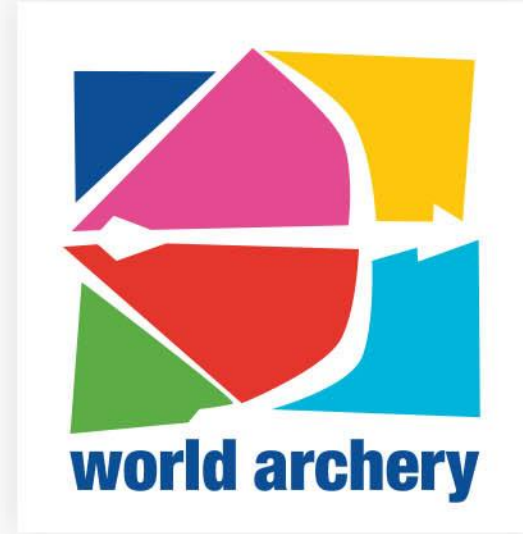

## Bylaw 16. Outdoor target face setup shoot off

- 14.5.2.1.1 Outdoors the target set-up for the shoot-off shall be as follows:
- For individuals there shall be one athlete per target butt on neutral target butts in the middle of the field. For Compound, only one 80cm six ring target face ~~for compounds~~ will be placed in the middle of the target butt;
- For each team the following setup will be used on neutral target butts in the middle of the field:
- For recurve or W1 (para), there will be one target butt with one single target face
- For Compound team, three 80cm-centres with triangular set-up.
- For Compound Mixed team or Para Doubles, two 80cm-centres with horizontal setup
- The individual team members shall decide wh

Reason: The existing rule did not clearly call out about the face setup that was to be followed for Mixed teams or Doubles for the Compound category. The same has been added basis the practice which is followed today in tournaments.

## **1. The participation rates, fees and license fees are very high. Why is it necessary to pay for a license if a registered person on the final list fails to travel? Is fair change intended?**

Because of the fact that the coverage of the insurance is already put in place, it is normal that it is invoiced. The deadline is the final deadline.

## **2. What about supporting federations that have recently joined the International Federation?**

Yes, through the same programmes that were just mentioned. It is written in the criteria that the age/membership is taken into account and usually giving advantage to the applicant.
