- The rules apply to everyone. The staff and judges who implement this are doing their job and should be respected. If not, there will be further consequences.

## Safeguarding research



#### Research survey for athletes - Harassment and Abuse in Sport

The Association of Summer Olympic International Federations (ASOIF) has initiated a pilot research study into the prevalence of harassment and abuse in elite sport. Six international federations are participating in this study of which one is World Archery.

#### **Summary:**

To allow C&R to revise the wording of the rulebook to lessen the use of terms with gender references.

#### Text:

• World Archery, working with the C&R Committee, is authorized to revise the Rule Book as World Archery deems reasonable and appropriate to lessen the use of gender references such as "he", "she", "him" or "her".



Articles: Book 1, Chapter 1, Article 1.6.5

#### **Summary:**

Clarification in wording for first vice president position regards to term limit + removing transitional procedure.

#### Text:

1.6.5 Persons elected to World Archery offices shall serve a term of four years unless otherwise specified with the following limitations:

- The person elected may serve a maximum of four full terms in the same committee or board (except the Executive Board) and must have a minimum two-year break after two consecutive full terms;
- The individual elected or appointed as the president, <u>first vice president</u>, vice president or a member of the
  Executive Board may serve a maximum of three full terms in the same position. Outgoing officer can be a candidate
  for a different position.

Transitional procedure: this rule (1.6.5.) will not be applied in 2019 and 2021 elections, but will be in full effect in the 2023 elections.

#### **Summary:**

To change deadlines in order to have Congress registration deadline before proxy deadline.

#### Text:

- 1.7.2 Each Member Association shall be allowed one voting delegate and no more than two other delegates, provided that if there are three (3) delegates in total, both sexes must be presented. Continental Associations and Associate International Federations may be represented by no more than two delegates. Associate Members may be represented by no more than one delegate. Each Member Association shall submit written authority signed by the Member Association naming its voting delegate and an alternative voting delegate at least 21 days 28 days before the start of Congress.
- 1.7.4 The vote of a Member Association may be cast by proxy only by another Member Association. No Member Association may carry more than one proxy, each proxy may only carry one vote. Each proxy shall be in writing, signed by the Member Association from which it is given and the Member Association which has accepted the proxy, and it shall be submitted to the Secretary General at least 30 days 21 days before the start of the Congress. No Member Association may give a proxy unless that Association is in good standing.

#### **Summary:**

Giving possibility to Executive Board to take certain urgent decisions in between Congresses or in certain conditions, add Congress motions after deadline.

#### Text:

Add the following bullet points to 1.12.6:

- When urgent, take decisions normally assumed by the Congress, except election of Executive Board Members, expulsion of a Member Association, changes to the Constitution and dissolution of World Archery. Any changes proposed by the Executive Board in an emergency situation will be circulated to the Member Associations and if more than 50% of valid votes available from the Member Associations object in writing to the Executive Board within 3 working days of notice being given, the change will not be implemented, and the matter will be referred to the next Congress. Otherwise, the Executive Board's decision to revise the rule(s), to suspend a Member Association or other matter for the urgent situation will stand until the next Congress. In such a case the decision, if it is to be made permanent, must be approved by the next Congress in accordance with the constitutional requirements at that Congress.
- The Executive Board may propose an item to the Congress as an 'Emergency Motion' without the prescribed notice period. These items may be considered by the Congress if two-thirds (2/3) of all eligible Member Associations are represented and two-thirds (2/3) of the votes submitted are in favour of consenting to deal with it.

1.12.8 The **decisions** Minutes of Executive Board meetings (including the budget) shall be <del>published and</del> circulated to all Members and officers.

Removing the appointment of anti-doping administrator from the Executive Committee duties as it is delegated to Anti-Doping division of the Court of Arbitration for Sport.

#### Text:

1.13.5 The Executive Committee shall appoint an Anti-Doping Administrator.



Articles: Book 1, Chapter 1, Article 1.13.6

#### **Summary:**

Removing the nomination of anti-doping panel from the Executive Committee duties as it is delegated to International Testing Agency.

#### Text:

1.13.6 The Executive Committee shall nominate the Anti-Doping Panel.

1.13.6.1 The Executive Committee delegates first-instance authority to adjudicate alleged anti-doping rule violations and sanctions to the Anti-Doping Division of the Court of Arbitration for Sport (CAS ADD), a separate Division of CAS, and in doing so, accepts the CAS ADD Rules to apply to any doping- related procedure. To the extent any procedural rules set out in the World Archery Anti-Doping Rules conflict with the CAS ADD Rules, the CAS ADD Rules shall prevail.

Removing the appointment of TUE from the Executive Committee duties as it is delegated to International Testing Agency.

Text:

1.13.7 The Executive Committee shall appoint the Therapeutic Use Exemption (TUE) panel.

#### **Summary:**

Editorial: to remove contradiction in the wording, because based on previous Congress decisions - Board of Justice and Ethics is appointed, not elected.

#### Text:

1.14.1 Congress shall elect **appoint** a Board of Justice and Ethics of five members to investigate alleged breaches of the World Archery Constitution and Rules, including its Code of Ethics and Conduct by any members of the World Archery Family. However, the Board of Justice and Ethics does not consider Anti-Doping Rules violations which are under the responsibility of the Anti-Doping Panel. The same procedure will apply for cases of safeguarding when confidentiality reasons might need a different process as defined in the Procedures on the Safeguarding.



Articles: Book 1, Chapter 2, Article 2.2.1

#### **Summary:**

Editorial: To delete existing comment on application as it is already in effect.

#### Text:

Article 2.1.1 is amended to read as follows:

2.1.1 Athletes, coaches and officials who wish to be part of their National Teams at events, which are recognised or controlled by World Archery, in one or more of the various disciplines recognised by World Archery, shall be affiliated with a Member Association and have a valid international license. For National Tournaments, the affiliation with a Member Association is necessary.

Removing: (until such time that the Executive Board adopts bylaws as to international license requirements, an athlete's, coaches' and official's membership in his Member Association shall constitute a valid international license.)

#### Related bylaw:

Article 2.1.1.1 to remain as it is. For clarity reasons, it is included in the motion:

Athletes, coaches and officials who wish to participate as part of a national team in Championships, World Cups or other events for which the registration is through the online entry system controlled by World Archery, in one or more of the various disciplines recognised by World Archery, shall be affiliated with a Member Association and have a valid international license.

Creating U15 age category for youth. Note: this does NOT create new world records or include them in World Championships programme. Just as a suggestion for national federations to use.

#### Text:

#### 4.2.1 Add:

- Under 15 Women
- Under 15 Men

Insert new article between current articles 4.2.2.1 and 4.2.3 to read:

• An athlete may participate in an Under 15 Class in tournaments when the competition takes place up to and in the year of his 14th birthday.

#### Article 4.4 Insert:

- Recurve Under 15 Women
- Recurve Under 15 Men
- Compound Under 15 Women

- Compound Under 15 Men
- Barebow Under 15 Women

#### Insert new article in section 4.5.1

- The 50m Round for Recurve U-15 consists of 72 arrows shot at 50 meters on the 122cm target face.

- The 40m Round for Compound U-15 consists of 72 arrows shot at 40 meters on the 80cm target face (6 rings)


Following the submission of motions and amendments a conference call took place to come with a compromise amendment in relation to motion 12 on the U15 category. Participants of the conference call were the original mover of the motion as well as all submitters of amendments (Sweden provided their input after the call). The following was agreed by all concerned:

#### A compromise amended motion will be proposed called Target Committee/ESP that states:


- \* U15 recurve will shoot 40m on a 122cm face
- \* U15 compound will shoot 40m on a 80cm face (depending on the competition this can be 6 ring or full face)
- \* U15 barebow will shoot 40m on a 122cm face

A subsequent amendment supported by NZL and SWE will also be discussed that only has a change for **U15** barebow which will shoot 30m on 122cm face.











\* Only if the U15 motion will pass, U13 amendment from Target Archery Committee will be put to vote:

Recurve: 30 meters 122cm

Compound: 30 meters 80cm

Barebow: 30 meters 122cm

#### **Summary:**

Editorial: Clarification on para archery doubles round and that para archery does not have teams. Not changing the rules, just describing the rounds in a different location in the rulebook.

#### Text:

#### Reasoning:

The rounds for Para-archery are defined in the Book 2, in the same section that the able bodied competitions.

The Para Committee wishes that the competition are, when possible, in the same format for para-archers than for able bodied.

The change in teams for Para-archer (doubles instead of team of 3 archers) has to be considered in the text.

The proposal is to clarify this and to update the rule accordingly.

#### **Summary:**

<u>For field and 3D archery</u>: Change in the system of shooting eliminations - removing pools and keeping head to head matches.

#### Text:

Multiple articles involved, too long to include full text. Check the motion <u>here</u>.

#### Reasoning:

The introduction of the pool system has included head-to-head matches after qualification. It was designed to give those who shot better in qualification a benefit in the next round.

Since its introduction it has found to be hard to understand for some and complicated to run. The head-to-head element is enjoyed, and this proposal is designed to remove the complex system of the pools and keep the excitement and challenge of the head to head.

Changing 3D archery team composition from three to four to include all different bow categories.

#### Text:

The Team Elimination Round (quarter-finals) consists of the top eight teams in each class qualifying from the two Qualification Rounds shooting four targets each: A team shall be made up by one Compound athlete, one Longbow athlete and one athlete using either a Traditional athlete or a and one Barebow. The team ranking shall be based on the best athlete's results for each category after the second Qualification Round. (If both the Traditional and the Barebow division are competing the higher result shall be taken for the ranking);

# Motion 18 - withdrawn (bylaw, not a law)

### **Summary:**

Allowing all para athletes to stay on the shooting line (not only for wheelchair athletes)

#### Text:

Wheelchair **Para classified** athletes may stay on the shooting line throughout the match. They indicate that they have finished shooting by raising a hand above the head (see Chapter 21 - Para-Archery);

Clarifying the use of binoculars for field and 3D archery.

## Text (too long to include all, but new text would read as follows):

Add as Law:

22.7.1 Binoculars, scopes and other visual aids may be used subject to the following.

#### Add as Bylaws:

- 22.7.1.1 Binoculars, scopes and other visual aids may not have any visible scales or marks that can be used to range distances. Marks must be covered so that they cannot be seen or felt by the athlete, this includes those placed by manufacturers if they move when the focus dial is turned.
- 22.7.1.2 Prescription glasses, shooting spectacles and sunglasses may be used. None of these may be fitted with micro hole lenses, or similar devices, nor may they be marked in any way to assist in aiming.
- 22.7.1.3 Should the athlete need to cover the non-sighting eye and or glasses lens, plastic, film or tape may be used to obscure vision, or an eye patch may be used.

Clarification on use of mobile communication on the course.

#### Text:

Multiple articles involved, too long to include full text. Check the motion <u>here</u>.

#### Reasoning:

The promotion of the sport is vital. Mobile phones provide an instant way of communicating to social media what athletes are doing and how the sport is accessible to all.

To permit the use at non WRE or Continental and International events allows this promotion to transmit the sport and increase participation.

The restriction to events excluding WRE/Continental/International events, follows the line drawn in target with differing timing and stoppages between WRE/World Cup events and all other events.

### **Summary:**

Clarifies that coaches are not allowed on course for qualification and elimination and only in specific area for finals.

#### Text:

23.7. There is a limited access for coaches to courses during field and 3D rounds as follows:

#### **RELATED BYLAWS:**

- 23.7.1 There shall be no coaches permitted on qualification or elimination courses. Coaches must remain outside the boundaries set by the Technical Delegate.
- 23.7.2 Coaches are permitted on the finals field, however must remain in the coach area defined by the Technical Delegate unless required to shade the athlete and permission from the Chair of Judges has been granted prior to the session commencing.

# **Proposal 1**

### **Summary:**

Creating U30 age category for para archery instead of usual U18 and U21 age categories (results in creating 17 new categories).

## Reasoning:

The growing development of para-archery and the increasing participation of younger para-archers calls for the existence of a category in which archers under 30 years of age can compete among themselves. The World Archery Americas Para Archery Committee considered the statistics of participation of younger archers in international events in the last few years, as well as the fact that the percentage of archers who have had their disabilities since they were children is very low. Therefore, it is not practical to use for para archery the same age categories we have for the able-bodied.




The following **positions are up for appointment** at the Congress:
