The accepted participants, through their National Federations, shall request the link to take the E-learning modules and pay for the access pin. Once the E-learning final test has been passed, please send your certificate to sderiaz@archery.sport. The Judge committee will then give you the final approval to attend the seminar and you will be able to purchase the air ticket.

<u>Application forms must be signed by a national member association for the participant to sit the examination and receive any accreditation.</u>

Participants successful in the final examination will become a World Archery Youth Judge.

Participants must bring copies of the World Archery Constitution and Rulebook and World Archery Judge Guide Book – both available from the World Archery webpage www.worldarchery.org – and a magnifying glass.
