To Polish Archery Federation President By email

Lausanne, 15 October 2018

Dear President,

Following the passing of the deadline of the 10<sup>th</sup> October and no information that was received following the letters of World Archery of the 28<sup>th</sup> September to which we had no answer within the deadline of the 10<sup>th</sup> October and 31<sup>st</sup> August which you refused to answer, the Executive Board took a unanimous decision by postal vote to implement the decision of the Board of Justice and to suspend the Polish Archery Federation until the World Archery Congress unless the following matters will be resolved:

- A strict adherence to the roadmap the Polish Archery Federation approved and submitted to World Archery in your letter of the 14<sup>th</sup> August but with new to be defined deadlines for the regional assemblies as well as the national assembly and proof that it is being implemented by the Polish Archery Federation that can be verified by Price Waterhouse Coopers which we will appoint as our independent observer. Any costs related to this for World Archery will be invoiced to the Polish Archery Federation.
- A submission of the information requested in World Archery's letter of the 31<sup>st</sup> August which is the only way we can verify that the elections can be done in a fair and transparent manner and following general principles of good governance which are a requirement to stay as member of World Archery. This information has to be supplied to our Price Waterhouse Coopers observer in Polish and as soon as possible.

During the suspension Polish Archers can participate in international competitions that do not require a national team registration such as the Indoor World Series.

However any other entries for the World Archery Europe or World Archery Events will only be accepted when submitted through the Ministry of Sport and the access in WAORS will be deactivated as of today.







Furthermore, no accreditation will be given to officers of the Polish Archery Federation in such events. Any other matters will be decided by the Executive Board on a case by case basis until the suspension is lifted.

The entire Executive board is very sad that a founding nation must be suspended and we urge you to resolve this matter as soon as possible. Any other decisions taken by the Polish Archery Federation are for us considered null and void.
