Change Requested or Question:	 Addition to article 4.5.1.2 The Elimination Round, in which the top 104 athletes (mandarory for World Archery Championships) are seeded accordinging to their position in the Qualifying Round (see appendix 3 – Match Play Charts). They shoot a series of matches in groups, each match consisting of the best of five sets of three arrows for recurve and barebow, and five ends of three arrows for compound <u>and W1</u>; The Finals Round, in which the eight athletes remaining from the Elimination round shoot individual matches, each match consisting of the best of five sets of three arrows for recurve and barebow, and five ends of three arrows for recurve and barebow, and five ends of three arrows for recurve and barebow, and five ends of three arrows for recurve and barebow, and five ends of three arrows for matches shall beshot one after the other. The athletes shall shoot alternately one arrow at a time.
