Overruling shall not be allowed regarding non-appealable issues as the ones described in articles 19.2 and 19.3 (WA Rules Book 3). Re-number current article 3.11.4 as 3.11.5
7. Reason(s):	Our committee discussed the pros and cons of overruling at the request of the WA Secretary General. We believe overruling should be possible when a judge makes an evident mistake, but we do not think we should allow overruling on arrow calls; one of the factors being that everyone would like to have a second call, and the tournament will take a lot of extra time. To reduce possibilities of inaccurate arrow calls, our Committee will continue to work of improving the level of our judges, but will not recommend allowing the overruling of calls made by the judges.
